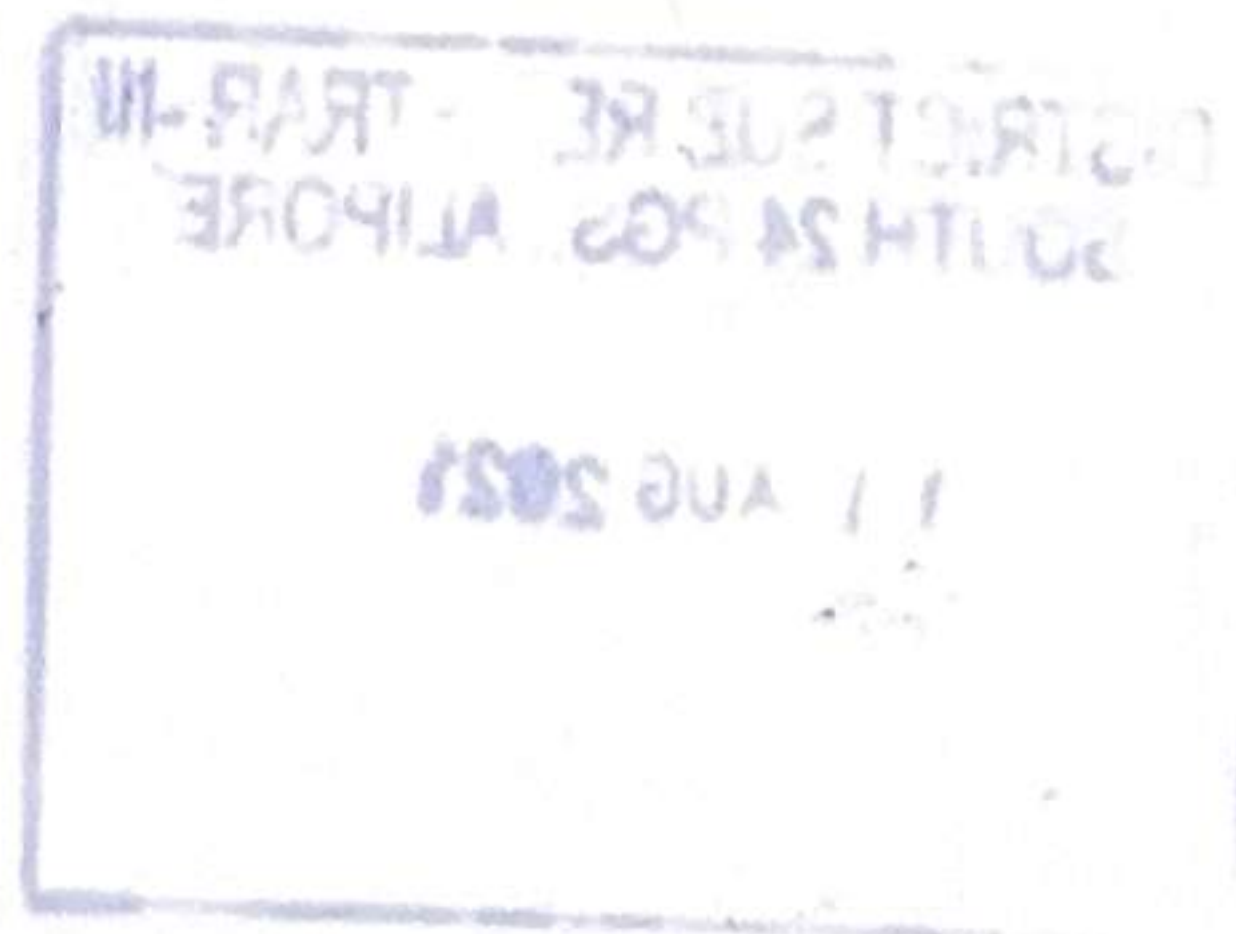
2. To their better enjoyment in future over their respective plots into a single plot of land, the Declarant herein amalgamates the said two respective plots of land into a single plot of land.
