And Whereas the Applicant, Erstwhile Promoter Company, has stated in his Affidavit that the consent of two-third existing Allottees, regarding prior approval to transfer the majority rights and liabilities of the erstwhile Promoter to the Intending Promoter, is not required in this case as they have not sold or allotted any unit, as on the date of cancellation of the Development Agreement with the Erstwhile Promoter and execution of New Development Agreement with the Intending Promoter, of the project named '**Gems Bougainvillas Phase -VIII**' situated at Bankarahat Road, Thakurpukur, Bishnupur - II, District - South 24 Parganas, PIN - 700104, as per the provisions of section 15(1) of the RERA Act, 2016;

And Whereas after careful examination of the submissions of the Authorized Representatives of both the Erstwhile Promoter and the Intending Promoter, which are placed on record, this Authority is of the considered view that the change in the developer / promoter is necessitated for proper construction and development of the instant project and the right and interest of the Allottees will not be affected as there is no allottee till date in the said project, as per the submission(s) of both the erstwhile and intending promoter(s) in their respective Affidavit(s) and necessary documentation and registration of documents shall be done by the concerned parties as per law

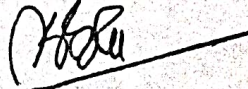


for the smooth transfer of the rights and liabilities of the Erstwhile Developer to the Intending Developer;

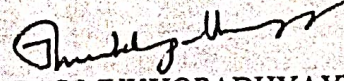
