

BIMAL MONDAL, son of Late Jatin Mondal by Suniti Mondal, by occupation Business, residing at A-7/1 Greenway, P.O. Pancharayer, P.S. Barrackpore, Kolkata 700 094, hereinafter referred to and/or called as the 'Lessor' (which term or expression shall unless excluded by its repugnancy to the context be deemed to mean and include his respective heirs, executors, administrators, legal representatives and assigns) of the 'OTHER PART'.

WHEREAS Sri Jatindranath Mondal, since deceased, son of Late Surendranath Mondal was the sole and absolute recorded owner of ALL THAT piece and parcel of land measuring more or less 46 sitka lying and situated under Mouza - Tentulberia, R.S.Das No.88, Khatian No. 425, J.L.No. 44.

AND WHEREAS during his life time the said Jatindranath Mondal had executed a Deed of Trust/Family Settlement, where he specifically mentioned that after completing marriage of all his daughters the entire property vested upon his four sons namely (1) SRI BIMAL KUMAR MONDAL, (2) SRI BISWESWAR MONDAL, since deceased (3) SRI BIKAS MONDAL and (4) SRI SATYENDRA NATH MONDAL and the said deed was registered in the Office of the Sub-Registrar at Alipore and duly recorded in Book No.I, Volume No.44, Pages 253 to 260 Being No. 1233 for the year 1979.




AND WHEREAS, after executing the said Deed of Trust/Family Settlement the said Sri Saindranath Mondal died intestate on 26th January, 1972.

AND WHEREAS after getting the right title, interest on the said landed property the said Bisveswar Mondal died intestate and leaving behind his wife namely Mrs. Rani Mondal one son namely Mr.Bisworoop Mondal and one married daughter namely Mrs. Bipasha Beru as per provision of Hindu Succession Act.



AND WHEREAS (1) Sri Bimal Kumar Mondal (A. S. C. I. M. D. L. and Agri-mono  
lental m. Smt. Nitinam Barua and (2) Sri Jites Mondal duly partitioned their  
property by virtue of a Deed of Partition which was duly registered in the  
Office of the R.D.S. P. Sonarpur and recorded in Book No. I, Regd. No. 11078  
for the year 2011 and by virtue of the said deed Sri Bimal Kumar Mondal  
getting ALL THAT piece and parcel of land measuring more or less 6 Gottahs  
15 Ghittaks 14 Sq.ft. the details of the property is more fully and particularly  
described in SCHEDULE - "A" hereunder written and enjoying the same free from  
all sorts of encumbrances.



AND WHEREAS in consideration of natural love and affection the Donor bears

is estimated to be Rs. 1,00,000.00 (Rupees one lac) only.


BY THIS DEED WITNESSES that :-




SITE PLAN PART OF R.S. DRC NO. 88 & E DRC NO. 93




