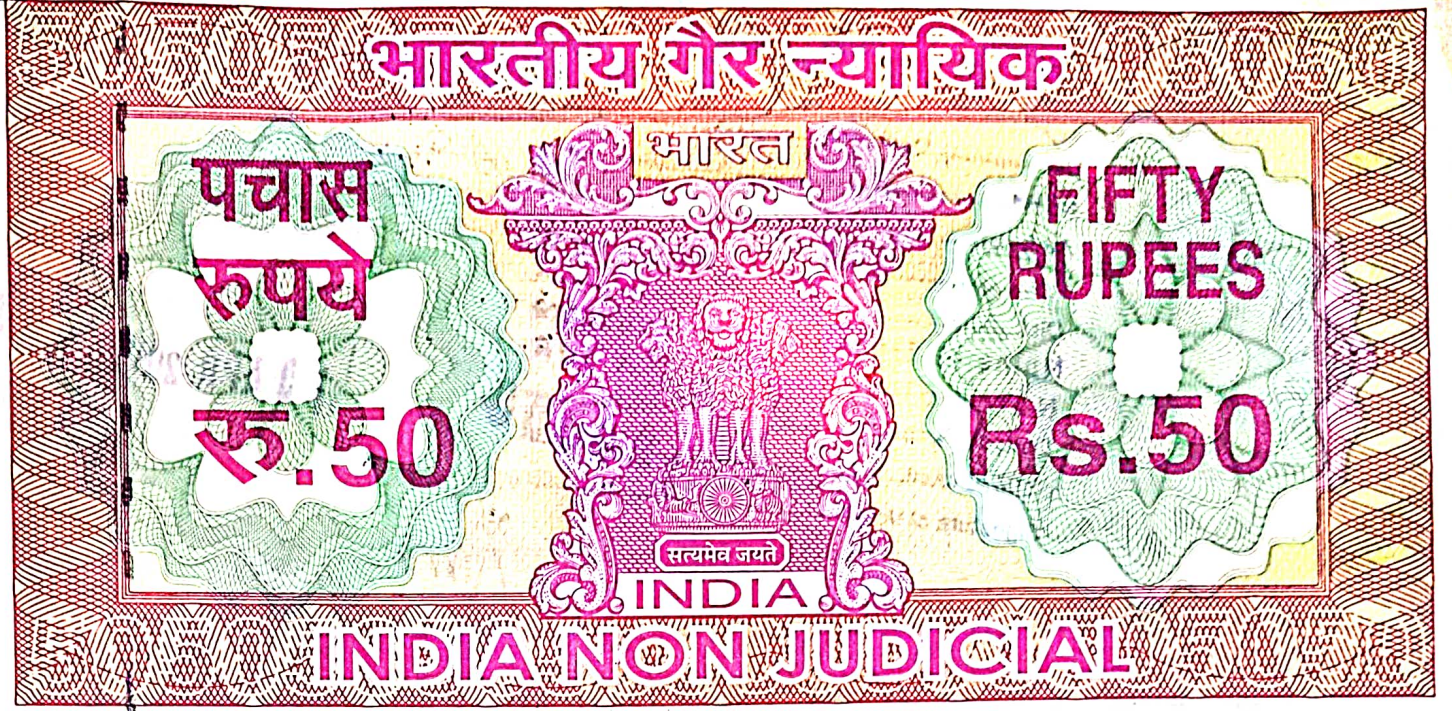
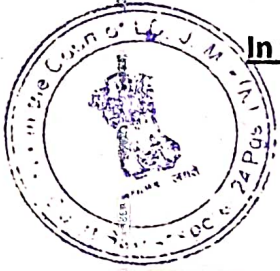

AFFIDAVIT

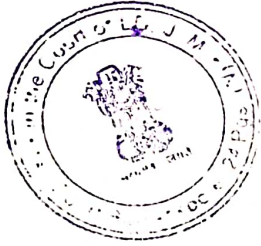

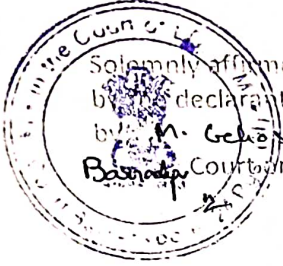
