## AFFIDAVIT

I, SRI SUJIT BOSE, S/o Late Jiban Krishna Bose, aged about years, by faith- Hindu, by occupation- service, by Nationality- Indian, residing at 2/H/10, Beliaghata Main Road, P.S.- Beliaghata, Koikata-700035, W.B. do hereby solemnly affirm and declare as follows :-

- 1. That one Smt. Ashalata Bose was seized and possessed of al that 06 sataks equivalent to as per local measurement 03 cottahs 11 chittaks of land now within the jurisdiction of the Kolkata Municipal Corporation within Ward No.111, now known as and numbered as 87, Subhas Pally, Police Station Regent Park now Bansdroni, Kolkata-700084, constructed a structure thereon was paying municipal taxes regularly and enjoying the same free from all encumbrances.
- 2. That said Smt. Ashalata Bose during her life time on 05.03.1990 executed her last Will and testament wherein and whereby she bequeathed all that 06 sataks equivalent to as per local measurement 03 cottahs 11 chittaks of land with structure now within the Kolkata Municipal Corporation within Ward No.111, now known as and numbered as 87, Subhas Pally, Police Station Regent Park now Bansdroni, Kolkata-700084, along with other properties situated at 2, Beliaghata Main Road, in the town of Kolkata in favour of her two sons namely (1) Sri Jiban Krishna Bose and

- 3. That said Smt. Ashalata Bose died on 03.12.1994 subsequently said (1) Sri Jiban Krishna Bose and (2) Sri Kanailal Bose filed an application for grant of probate in respect of his last Will dated 05.03.1990 before the Ld.District Delegate at Alipore, south 24 parganass vide Act 39 case No.190/95 and the Ld.Court was pleased to grant such probate vide order dated 22.01.1997 in favour of one (1) Sri Jiban Krishna Bose and (2) Sri Kanailal Bose.
- 4. That said (1) Sri Jiban Krishna Bose and (2) Sri Kanailal Bose thus became the joint owners of all that 06 sataks equivalent to as per local measurement 03 cottahs 11 chittaks of land now within the Kolkata Municipal Corporation within Ward No.111, now known and numbered as 87, Subhas Pally, Police Station Regent Park now Bansdroni, Kolkata-700084, having undivided half share each were administrating the said properties peacefully.

That said Sri Jiban Krishna Bose who was a Hindu, Governed by the Bengal School of Hindu Law died intestate on 18.12.2002 leaving behind surviving his wife Smt.Gouri Bose, one son Sri Sujit Bose and three married daughters namely (i) Smt. Tara Das, wife of Late Jiban Chandra Das, (ii) Smt. Dipali Das, wife of Goutam Das and (iii) Smt. Mithu Das, wife of Rajesh Das as his legal heirs, herein and successors only.

6. That as per law of inheritance and Hindu succession Act thus said (i) Smt. Gouri Bose, (ii) sri Sujit Bose, (iii) Smt. Tara Das, (iv) Smt. Dipali Das, (v) Smt. Mithu Das became the joint owners of all that undivided half share and Sri Kanailal Bose became the absolute owner of undivided half share premises No.87, Subhas Pally, Police Station Regent park now Bansdroni, Kolkata-700084 and enjoying the same free from all encumbrances.

That the above statements are true to the best of my knowledge and belief.
