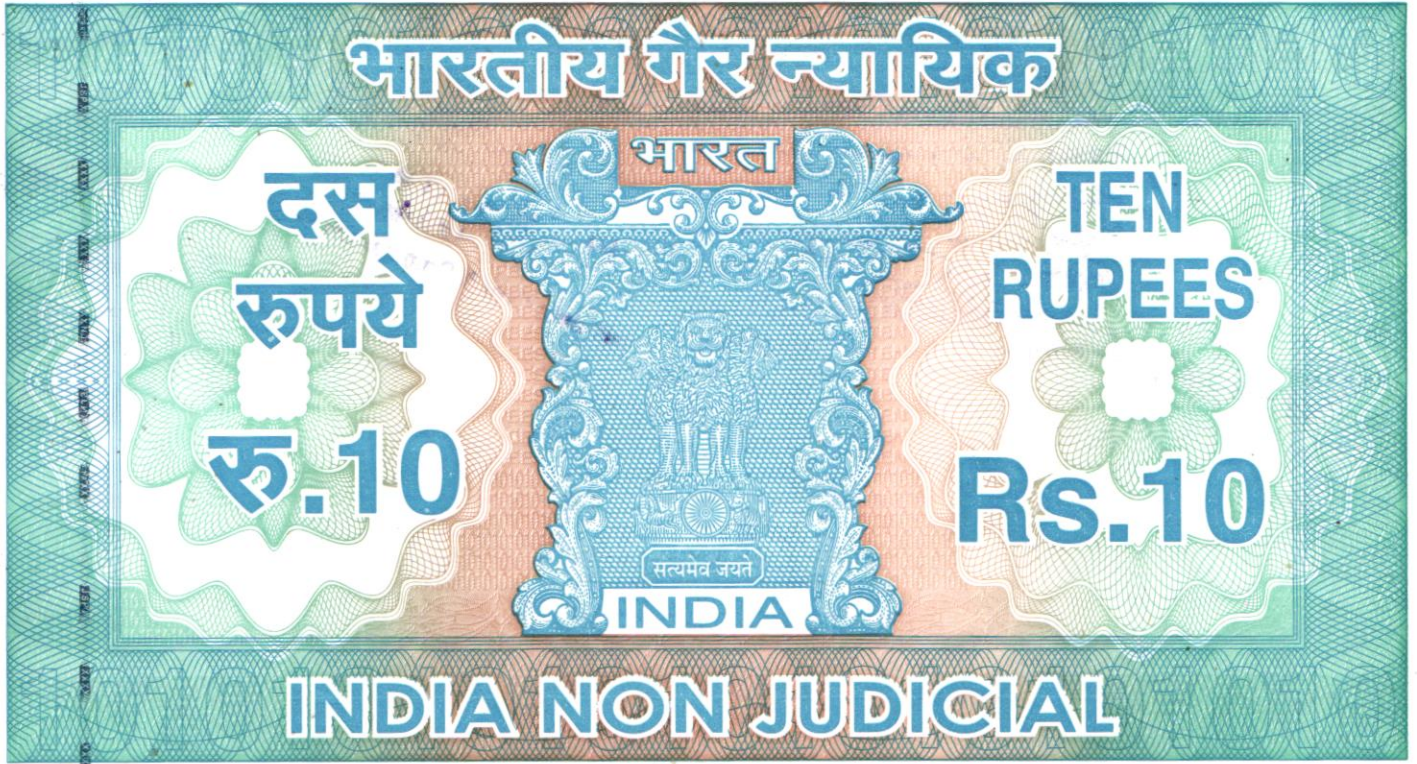

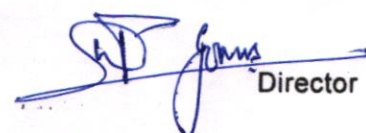
5.That, the amounts from the separate account to cover the cost of the project shall be withdrawn in proportion to the percentage of completion of the project.

8.That, we / promoter shall take all the pending approvals on time from the competent authorities.

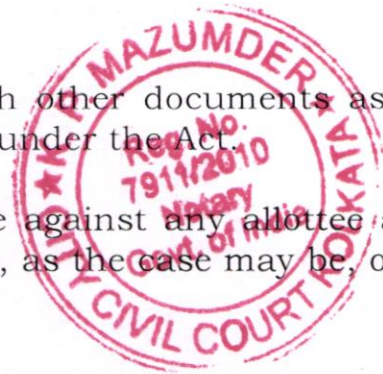

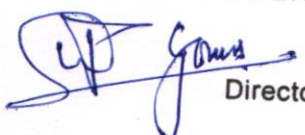

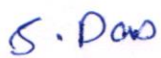
