

1. This is the Last Will and Testament of me, SATYENDRA NATH GHOSE son of Madan Mohan Ghose deceased, Hindu Kayastha, Landholder residing at No. 4, Haralal Mitra Street within Shampukur Police Station in the town of Calcutta. This my last Will and Testament shall come into force after my death.

2. I hereby revoke all my former Wills and Codicils at any time heretofore made. I also hereby revoke my Will dated 5th - January 1939 corresponding with 20th Pous 1345 B.S. (Registered at the office of the Sub-Registrar of Assurances, Calcutta, in Book No. III, Volume No. 3 at pages 60 to 67 Being No. 2 for the year 1939) and my Will dated 9th January 1956 (Registered at the office of the Registrar of Assurances, Calcutta, in Book No. III, Volume No. 1 at pages 32 to 35 Being No. 4 for the year 1956).

3. My present age is about 80 years. I am not keeping in good health always. My eldest son Sriman Makhanlal Ghose and my second son Sriman Promode Ranjan Ghose predeceased me. My family at present consists of (1) my wife Srimati Jiban Basini Ghose, (2) my youngest son Sriman Gopi Ranjan Ghose, who is upto now unmarried, (3) my second daughter Srimati Aparna Ghose, still unmarried, (4) my daughter-in-law Srimati Nilima Rani Ghose widow of my said son Makhan Lal Ghose deceased, (5) my grandson Sriman Shankar Prasad Ghose only son of my said son Makhan Lal Ghose deceased, (6) Kumari Seba Ghose and (7) Kumari Mita Ghose two unmarried daughters of my said son Makhanlal Ghose deceased, (8) Srimati Gouri Rani Ghose, widow of my said second son - Promode Ranjan Ghose deceased, (9) Sriman Shyama Prasad Ghose and (10) Sriman Sudhis Ranjan Ghose, two sons of my said second son Promode Ranjan Ghose deceased, and (11) Kumari Dipti Ghose

unmarried daughter of my said second son Promode Ranjan Ghose deceased.

4. My properties, inter-alia, consists of the following:-

- (a) House and premises No. 4, Haralal Mitra Street, - Bagbazar, in Sutanutty in the North Division of the town of Calcutta.
  - (b) House and premises No. 16, Jiban Krishna Mitra Road, Paikpara within Chitpur Police Station in the District of 24-Parganas but within the Municipal limits of the town of Calcutta.
  - (c) Land and premises being premises No. 374, Maharaja - Nanda Kumar Road North, within Baranagore Police - Station in the District of 24-Parganas.
  - (d) Suna lands measuring .95 Acre in Dag Nos. 55 and 99 of Khatian No. 91 in Touzi No. 218 and 3989 Hooghly at Satgachhi, Mouza Bundebaj, Pargana Patmahal Kalyanpur within Kalna Police Station, Sub-Registration District Kalna in the District of Burdwan.
  - (e) Twenty-five per cent share in the partnership business carried on under the name and style of Eastern Electric Company at 41 and 42, Dharamtolla Street, Calcutta and 138/1, Bidhan Sarani (Cornwallis Street), Calcutta.
- Seventy per cent share in the partnership carrying on business as Agents of Fire and Marine Insurance under name and style of Messrs. S. N. Ghose & Sons (Fire and Marine Insurance Agency) at premises No. 4, Haralal Mitra Street, Calcutta.

5. I give devise and bequeath unto and to the use of my wife Smt. Jiban Basini Ghose for life as follows:-

6. After the death of my said wife Sm. Jiban Basini Ghose the said one-sixth share of and in both the premises No. 4, - Haralal Mitra Street, Calcutta and 16, Jiban Krishna Mitra Road, Calcutta, will devolve absolutely in equal shares on my said son Sri Gopi Ranjan Ghose and my said grand-sons Sriman Shankar Prasad Ghose, Sriman Shyama Prasad Ghose and Sriman Sudhis Ranjan Ghose or their respective male heirs and successors and the said twelve and a half per cent share out of my twenty-five per cent share in the said partnership business of Messrs. Eastern - - Electric Company will devolve absolutely on all the partners of the said Messrs. Eastern Electric Company living at the time of death of my said wife in equal shares.

7. I give devise and bequeath to my said son Sriman Gopi Ranjan Ghose absolutely the following:-

- (1) Undivided one-third share of and in both the houses and premises No. 4, Haralal Mitra Street, Calcutta and No. 16, Jiban Krishna Mitra Road, Calcutta.
- (ii) Undivided one-third share of and in the said Suna lands at Satgachhi, Mouza Bundabaj in the District of Burdwan.
- (iii) Undivided one-third share of and in the said land and premises No. 374, Maharaja Nanda Kumar Road - North, Baranagar, 24-Barganas.

8. I give devise and bequeath to my said grand-son Sriman Shyama Prasad Ghose absolutely the followings:-

- (i) Undivided one-sixth share of and in both the houses and premises No. 4, Haralal Mitra Street, Calcutta and No. 16, Jiban Krishna Mitra Road, Calcutta.
- (ii) Undivided one-sixth share of and in the said Suna lands at Satgachhi, Mouza Bundebarj in the District of Burdwan.
- (iii) Forty per cent share out of my seventy per cent - share in the said partnership business of Fire and Marine Insurance under the name and style of Messrs. S. N. Ghose & Sons (Fire & Marine Insurance Agency).

9. I give devise and bequeath my said grand-son Sriman Sudhis ~~XXXXXX~~ Ranjan Ghose absolutely the followings:-

- (i) Undivided one-sixth share of and in both the houses and premises No. 4, Haralal Mitra Street, Calcutta and No. 16, Jiban Krishna Mitra Road, Calcutta.
- (ii) Undivided one-sixth share of and in the said Suna lands at Satgachhi, Mouza Bundebarj in the District of Burdwan.
- (iii) Thirty per cent share out of my seventy per cent share in the said partnership business of Fire and Marine Agency under the name and style of Messrs. S. N. Ghose & Sons (Fire Agency).

10. I give devise and bequeath to my said grand-son Sriman Shankar Prasad Ghose absolutely the followings:-

- (i) Undivided one-sixth share of and in both the houses and premises No. 4, Haralal Mitra Street, Calcutta and No. 16, Jiban Krishna Mitra Road, Calcutta.

(11) Undivided one-third share of and in the said Suna Land at Satgachhi, Mouza Bundebarj in the District of Burdwan.

11. I give devise and bequeath to my said daughter Sm. Aparna Ghose for life the twelve and a half per cent share out of my twenty five per cent share of and in the said partnership business of Messrs. Eastern Electric Company to be enjoyed by her during her natural life. After the death of my said daughter Sm. Aparna Ghose, the said twelve and a half per cent share will be divided in equal shares to all the partners of the said Messrs. Eastern Electric Company living at the time of her death.

12. I give devise and bequeath to my daughter-in-law Sm. Nilima Rani Ghose for her life one-third share of and in the said land and premises No.374, Maharaja Nanda Kumar Road North, Baranagore, 24-Parganas, to be held and enjoyed by her during her natural life. After her death the said one-third share will devolve on my said grand-son Sriman Shankar Prosad Ghose taking absolutely two-third share thereof, that is, two-ninth of the said entire land and premises No. 374, Maharaja Nanda Kumar Road North, Baranagore and on my said grand-son Sriman Shyama Prasad Ghose taking absolutely one-sixth share thereof, that is, one-eighteenth share of the said entire land and premises No.374, Maharaja Nanda Kumar Road North, Baranagore and on my said grand-son Sriman - Sudhis Ranjan Ghose taking absolutely the remaining one-sixth share thereof, that is, one-eighteenth share of the said entire land and premises No. 374, Maharaja Nanda Kumar Road North, Baranagore.

13. I give devise and bequeath to my daughter-in-law Sm. Gouri Rani Ghose for her life one-third share of and in the said land and premises No.374, Maharaja Nanda Kumar Road North, Baranagore, 24-Parganas, to be enjoyed by her, during her natural

After her death, the said one-third share will devolve on my said grand-son Sriman Shyama Prasad Ghosh taking absolutely - half of the said one-third share, that is, one-sixth share of the said entire land and premises No. 374, Maharaja Nanda Kumar Road North, Baranagore and on my said grand-son Sriman Sudhis Ranjan Ghose taking absolutely the remaining half of the said one-third share, that is, one-sixth share of the said entire land and - premises No. 374, Maharaja Nanda Kumar Road North, Baranagore.

14. My daughter-in-law Srimati Nilima Fani Ghose and her said two unmarried daughters Kumari Seba Ghose and Kumari Mita Ghose, living together, will have the right of residence either at the said house and premises No. 4, Haralal Mitra Street, - Calcutta or at the said house and premises No. 16, Jiban Krishna Mitra Road, Paikpara, Calcutta with her son Sriman Sankar Prasad Ghose in his one-sixth share of the said properties provided that the said respective right of residence of the said two unmarried daughters will terminate on their respective marriages. My - daughter-in-law Srimati Gouri Rani Ghose and her said unmarried daughter Kumari Dipti Ghose living together, will have the right of residence either at the said house and premises No. 4, Haralal Mitra Street, Calcutta or at the said house and premises No. 16, Jiban Krishna Mitra Road, Paikpara, Calcutta with her sons Sriman Shyama Prasad Ghose and Sriman Sudhis Ranjan Ghose or one of them in their respective one-sixth share of the said properties, - provided that the said right of residence of the said unmarried daughter will terminate on her marriage. My daughter Srimati Aparna Ghose will have the right of residence in the house and premises No. 4, Haralal Mitra Street, Calcutta.

15. I give devise and bequeath all moneys payable in respect of my various Insurance Policies to my wife Jiban Basini Ghose absolutely.



16. I give devise and bequeath the rest and residue of my estate and all my moveable properties including various shares in joint stock Companies and moneys lying at Banks absolutely to my son Sriman Gopi Ranjan Ghose taking one-third thereof and my grand-sons Sriman Shyama Prasad Ghose, Sriman Sudhis Ranjan Ghose and Sriman Sankar Prasad Ghose each taking two-ninth thereof

17. I appoint my said son Sriman Gopi Ranjan Ghose and my Solicitor Shri Sunil Kumar Mitra as executors of this my last Will and Testament and I direct that they shall act jointly and in concert.

18. I direct my executors to collect get in and possess all my properties and assets which I may die possessed of or be entitled to at the time of my death and to pay all my just debts and liabilities as also my funeral and testamentary expenses out of my estate.

IN WITNESS WHEREOF I, the said Satyendra Nath Ghose have hereunto set my hand this Seventh day of October One Thousand Nine Hundred and Sixty Four.
