SITE PLAN AS PER THE POSSN.

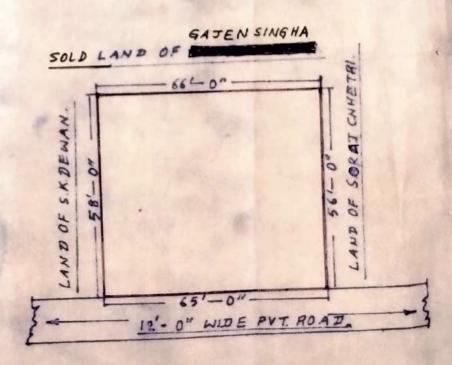
