A. SUBJECT PROPERTY:

ALL THAT the pieces or parcels of mokarari land having permanent tenure admeasuring about 2 bighas 1 cottah 10 chittaks and 20 square feet [more or less] together with structures admeasuring 3995 square feet more or less comprised in and known and numbered as **Municipal Premises No.381, Prince Anwar Shah Road, P.S. Jadavpur, P.O. Jodhpur Park, Kolkata-700068** [formerly a portion of Tollygunge Municipal Premises No.183E, Prince Anwar Shah Road, Kolkata-700068] comprised in Plots No. 87,88,89,90 and 91 in Poddar Park and included in and forming part of CS Plots No.710 and 711, Khatian No. 643 and also portion of CS Dag No.706, Khatian No.640, J.L.No.39, RS No.42 within Touzi No.151 of the Collectorate of 24-Parganas, Mouza- Asokpur, Pargana-Haspur, Sub-Registry Alipore, District South 24-Parganas [formerly 24-Parganas].

B. RECORDED OWNERS:

AAR SHREE INTERSTATE PRIVATE LIMITED; and

KALPANA SHREE INTERSTATE PRIVATE LIMITED;

Both having its registered address at 2, Middleton Row, 2nd Floor, P.S. Shakespeare Sarani, P.O. Park Street, Kolkata 700071 [hereinafter referred to as the '**OWNERS**'].

C. SEARCH REPORT

Under instructions from Park Chambers Limited (Client), I had conducted searches in the Registration Offices and the Courts having jurisdiction over the Subject Property, and rendered a Report dated 1st July 2023.

I have been further instructed to cause further search in respect of the Subject Property for the years 2023 and 2024.

The findings recorded below should be read with the findings given by me in my Report dated 1st July 2023 and the present Report shall always be read in conjunction with my Report dated 1st July 2023.



The findings from the searches caused for the years 2023 and 2024 are as follows:-

- I. Registration Offices: Searches were caused to be made of the relevant Index-I and Index-II at the offices of the Registrar of Assurances/ Additional Registrar of Assurances- I, II, III and IV, District Registrar, Alipore and the Additional District Sub-Registrar, Alipore for the years 2023 and 2024. The receipts (8 in number) issued by the concerned Registration Offices from time to time are annexed hereto and marked "A". Print outs of print screens of the entries as available on the website www.wbregistration.gov.in are annexed hereto and marked "B".
- II. No adverse entries have been found in course of searches made. The only entries found are the development agreement entered into by and between the **Owners** and the **CLIENT**; the Development Power of Attorney executed by the Owners in favour of the Client; Gift of strip of land in favour of KMC; Boundary Declaration and one corner splay deed executed by the Owners. There is also an entry disclosing a second corner splay Deed for the year 2025 which is revealed from searches made on the website www.wbregistration.gov.in. These entries obviously relate to the statutorily required documents for sanction of building plan.
- III. I would like to, however, indicate the following Caveats as regards such search:
 - a) Since the introduction of Section 47A of the Indian Stamp Act, 1899, as applicable to West Bengal, documents, which have been presented for registration, but registration whereof has been kept pending for want of assessment of market value by the Registering Authority, do not reflect in the searches and get recorded in the indices only upon payment of deficit stamp duty and registration fee applicable thereon, although such documents take effect from the date of their execution;
 - b) For the period for which searches have been carried out, the records of the Registration Offices are computerized and indices are not maintained therein for public inspection. The Report of the Searcher is based on oral details given by the Clerk sitting on the Computer and on the basis of the searches made on the website www.wbregistration.gov.in;

IV. COURTS

Searches were made as to whether any Title Suit or Money Suit were filed in the Courts of the Learned 5th Civil Judge (Senior Division), Alipore and the

Learned 1st Civil Judge (Junior Division), Alipore, against the Companies, who are the present owners of the Subject Property during the years mentioned therein and up to the respective date of issuance of the Search Information Slips. From the aforesaid Information Slips, it would appear that no Title Suit or Money Suit has been filed against the Companies, being the present owners of the Subject Property. Copies of the Information Slips are annexed herewith and marked “C”.

- V. Further confirmatory searches made on the website of the Kolkata Municipal Corporation show the names of the Companies, being the owners of the Subject Property, to be recorded as the owners in the records of the Kolkata Municipal Corporation in respect of the Subject Property.
- VI. From the documents supplied by the Client along with the instructions to cause further searches, it appears that several Certificates of Enlistment were outstanding in respect of the Subject Property, even though the same were not all being renewed every year. It appears that all the Certificates of Enlistment have since been closed.

D. REGISTRAR OF COMPANIES:

The client has also forwarded to me two reports of M.R. and Co., both dated 12th February, 2025, for searches made by them of the Owner Companies. From the said report it appears that both the companies are compliant with all statutory requirements under the Companies Act, 2013. No charge is disclosed as subsisting on the Subject Property in the said Report. However, a Memorandum of Entry was found to have been executed on 29.10.2019 by AAR SHREE Interstate Private Limited whereby the title deeds of AAR SHREE Interstate Private Limited were mortgaged with Kotak Mahindra Bank as security for facilities obtained by Kamarhatty Co. Ltd. The Owners have also supplied through the client a letter dated 6th April, 2023 issued by Kotak Mahindra Bank to the effect that the said property has been released from security and the Original Title Deeds have been made over by Kotak Mahindra Bank to AAR SHREE Interstate Private Limited. The charge on the Subject Property which was created so far as the portion of AAR SHREE Interstate Private Limited therefore stood vacated.

E. CHAIN OF TITLE

- A. By an Indenture of Conveyance dated 11th August, 1941 executed by and between the Calcutta Credit Corporation Ltd. [therein described as the ‘Vendor’] and Smt. Munni Devi [therein described as the ‘Purchaser’] registered in the office of the District Registrar, 24-Parganas, Alipore and recorded in Book No. I, Volume - 29 at pages 276 to 289 thereof and numbered as Deed No. 1596 for the year 1941, the aforesaid Calcutta Credit Corporation Ltd. sold, granted, conveyed, transferred, assigned and assured unto and in favour of the said Smt.



Munni Devi **ALL THAT** the piece and parcel of Mokarari land held in permanent tenure right in Poddar Park containing by measurement an area of 2 (two) bighas 1 (one) cottah 4 (four) chittaks and 20 (twenty) Square Feet situate lying at and being a portion of Tollygunge Municipal Premises No. 183-B, Prince Anwar Shah Road, Calcutta and which is now known numbered and described as Municipal Premises No. 381, Prince Anwar Shah Road, Kolkata [Poddar House] within the local limits of the erstwhile Tollygunge Municipality [now comprised in the Kolkata Municipal Corporation] morefully mentioned and described in the schedule thereunder written [hereinafter referred to as the ‘**Subject Property**’]

- B. Smt. Munni Devi died on 11th May, 1955 after making and publishing her Last Will and Testament dated 1st January, 1955 whereby and whereunder she appointed Janki Prasad Poddar and Hanuman Prasad Poddar as the Joint Executors to her said Last Will and Testament.
- C. In terms of the said Last Will and Testament, the Subject Property, which is now known, numbered and distinguished as premises No. 381, Prince Anwar Shah Road, Kolkata was bequeathed unto and in favour of her two grandsons, namely, Suresh Kumar Neotia and Vinod Kumar Neotia in equal share.
- D. Upon the death of Smt. Munni Devi on 11th May 1955, the executors named in the Last Will and Testament of Smt. Munni Devi, i.e. Janki Prasad Poddar and Hanuman Prasad Poddar, applied for probate of the Last Will and Testament of Smt. Munni Devi before the Hon’ble High Court at Calcutta, and probate thereof was granted to the said joint executors by the Hon’ble High Court at Calcutta on 6th July 1956 and issued to them on 10th July, 1956.
- E. By a Deed of Release dated 31st August, 1956 registered in the office of the Registrar of Assurances, Kolkata in Book No. I, Volume No. - 100 at pages 289 to 292 and numbered as Deed No. 41100 for the year 1956, the said joint executors of the Last Will and Testament of Smt. Munni Devi, since deceased namely, Janki Prasad Poddar and Hanuman Prasad Poddar assented to the legacy contained in the said Last Will and Testament of Smt. Munni Devi, since deceased, in respect of the Subject Property unto and in favour of Suresh Kumar Neotia and Vinod Kumar Neotia, the named beneficiaries therein.
- F. By an Indenture dated 31st March, 1973, Vinod Kumar Neotia sold, transferred, conveyed, assigned and assured his undivided half share in premises No. 381, Prince Anwar Shah Road, Kolkata unto and in favour of Suresh Kumar Neotia at and for the consideration mentioned therein. The said Indenture was registered in the office of the Registrar of Assurances, Kolkata and recorded in Book No.1, Volume-94 at Pages 22 to 32 and numbered as Deed No.1890 of 1973.
- G. By an Indenture dated 27th April, 1984, the aforesaid Suresh Kumar Neotia sold, transferred, conveyed, assigned and assured unto and in favour of Kalpana



Shree Interstate Private Limited the demarcated eastern, western and southern portions of Municipal Premises No. 381, Prince Anwar Shah Road, Kolkata measuring 19 cottahs 11 chittaks and 20 Square Feet as demarcated in the map and/or plan annexed to the said conveyance. The Indenture dated 27th April, 1984 executed in favour of Kalpana Shree Interstate Private Limited was registered in the office of the Registrar of Assurances, Kolkata and recorded in Book No. I, Volume No. 21 at pages 25 to 40 and numbered as Deed No. 4789 of 1984.

- H. By a further Indenture also dated 27th April, 1984 the aforesaid Suresh Kumar Neotia sold, transferred, conveyed, assigned and assured unto and in favour of Aar Shree Interstate Private Limited the demarcated north, east and west portions of the said premises No. 381, Prince Anwar Shah Road, Kolkata admeasuring 1 bigha 1 cottah 9 chittaks more or less together with the brick built building and the structures thereon as demarcated in the map and/or plan annexed to the said conveyance. The Indenture dated 27th April, 1984 executed in favour of Aarshree Interstate Private Limited was recorded in Book No.1, Volume 21 at Pages 41 to 63 and numbered as Deed No. 4790 of 1984.
- I. By virtue thereof the owners herein have become absolutely entitled to the Subject Property morefully described in the First Schedule hereunder written.

F. DISCLAIMERS

The Report and the Opinion herein contained should be read, subject to the following disclaimers:

- (i) The objective of this Report is to highlight any adverse observations associated with the title of the Companies, being the owners of the Subject Property, upon review of the documents and information provided to me, and the result of the searches caused to be conducted by us through local searchers and information available on Government websites and disseminated by the Office of the Courts having jurisdiction over the subject property;
- (ii) With respect to the records maintained by the Kolkata Municipal Corporation, I have relied on the information made available by the Kolkata Municipal Corporation on their website for public viewing.
- (iii) With respect to the records of the ROC, Kolkata, I have relied on the report of M. R. and Co. appointed by the client for causing search of the records in the ROC so far as the Owner Companies are concerned, the Memorandum of Entry and the letter dated 6th April, 2023 of Kotak Mahindra Bank provided to me by the Client who has been forwarded the same by the Owners.



- (iv) This Report is issued on the basis of the records available as on the date of searches caused to be done;
- (v) The search undertaken does not relate to any encumbrance and/or charge created by operation of law, inter alia, on account of default in payment of statutory levies and taxes, such as, Income Tax, Goods and Services Tax, Customs Duty, Excise Duty, Value Added Tax etc. or by any statutory authority empowered under any Statute and relates only to encumbrances created by act of parties, which are required in law to be recorded and maintained for the public in general at offices in which I have caused searches made as above;
- (vi) This Report is prepared and made exclusively for the Client and shall not be used or relied upon by any other person;

G. FINDING

On the basis of the facts stated above, and subject to the comments made in the preceding portions thereof or in the annexures hereto, the searches caused, did not disclose any encumbrance affecting the Subject Property.

As already indicated above, the present Report is to be read in conjunction with my earlier Report dated 1st July 2023.




