Your site is located at a distance 4713 mts from ARP and lies in the grid W14 of the published CCZM of Behala airport. The Permitted top elevation for this grid is 33 mts.

Since the requested top elevation 26.45 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.

Applicants also need to seek clearance from state Govt. as applicable, for sites which lies in the jurisdiction of unlicensed civil aerodrome as outlined in Rule 13 of GSR751 (E).
