- 1. That (1) SMT TRIPTI CHJATTERJEE ,(2 SRI SAIKAT CHATTERJEE,(3) SMT JHARANA CHATTERJEE ,(4) SRI SANDIP CHATTERJEE ,(5) SMT MITA CHATTERJEE ,(6) SMT NITA SOM all of whome residing at 28/10A Barisha purba road,PS-Haridevpur,Kolkata -700063 has a legal title to the land on which the development of the project is proposed AND a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

That I/promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That I / promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That I / promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That I / promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
