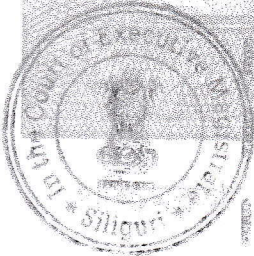

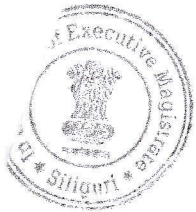

That my father Late Manindra Nath Dutta, Son of Late Bijay Gobinda Dutta and my maternal uncle Nipendra Nath Nandi, Son of Late Jatish Chandra Nandi jointly purchased a piece and parcel of land measuring 0.251 Acres appertaining to and forming part of Plot No. 6301, J. L. No. 110 (88), Mouza – Siliguri – Baikunthapur, Police Station – Siliguri, Dist – Darjeeling.

2. That being joint owners in such possession above named Nipendra Nath Nandi and Manindra Nath Dutta mutated thir names in the Record-of-Rights in respect of land measuring 0.251 Acres and separate Khatians were published in their names being Khatian Nos. 3592 & 3588 respectively and thereby acquiring the said land in their khas actual and physical possession having permanent heritable and transferable right, title and interest therein.
