3. That my grandparents were predeceased a long year ago.

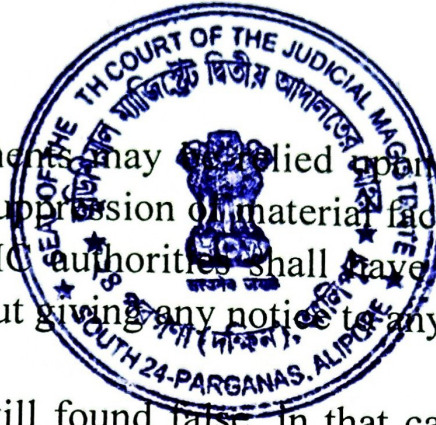

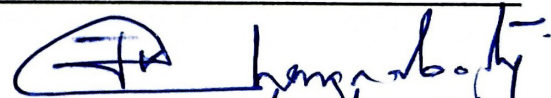
