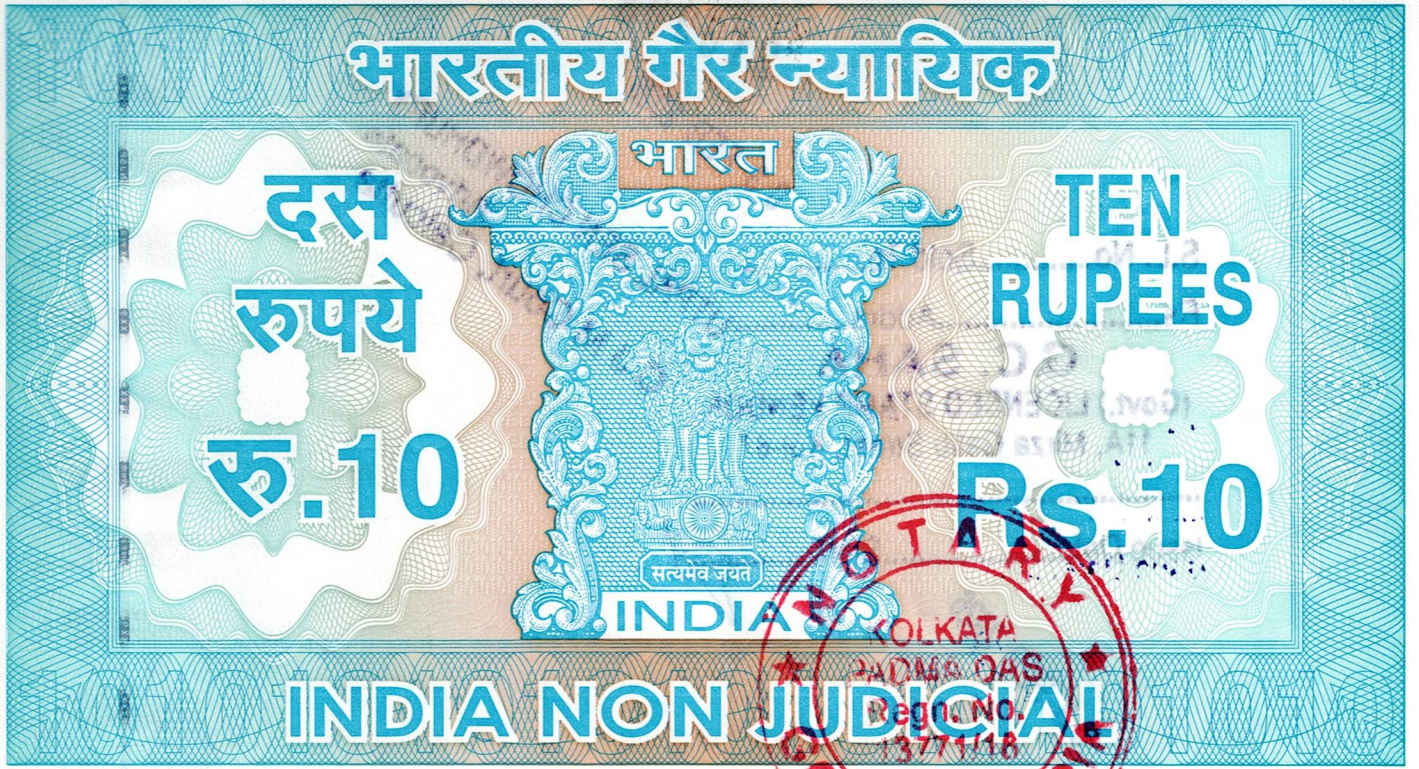

4. That the seventy percent of the amount realized by promoter for the real estate project from the allottees , from time to time , shall be deposited in a separate account to be

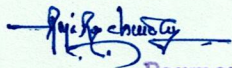

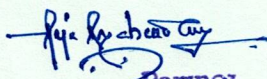

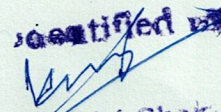
