- 3. That the time period within which the project shall be completed by me /promoter is 24/08/2025
- 4. That seventy per cent of the amounts realized by me/promoter for the real estate project of estate project from the allottees, from time to time, shall be deposited in a separate agent and the cost of separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose.
