 That, KAMAL SARKAR, BHARATI SARKAR, BINA HALDER, KARUNA SARKHEL, TAPAS GHARAMI, BAISHAKI SARDAR & NILAM SARADAR have a legal title to the land on which the development of the proposed project is to be carried out, AND

A legally valid authentication of title of such land of the real estate project along with Development Agreement and Power of Attorney is enclosed herewith.

- 2. That the said land is free from all encumbrances.
