



2. That the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by **M/S. T & A DEVELOPER** /promoters is 29.06.2027.
4. That seventy (70) per cent of the amounts realised by **M/S. T & A DEVELOPER** for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

10. That I/ promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.




