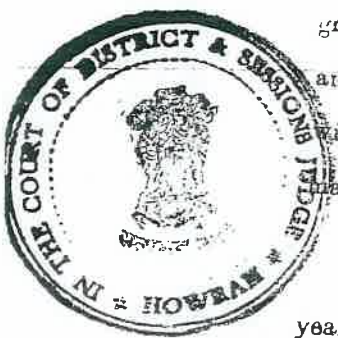

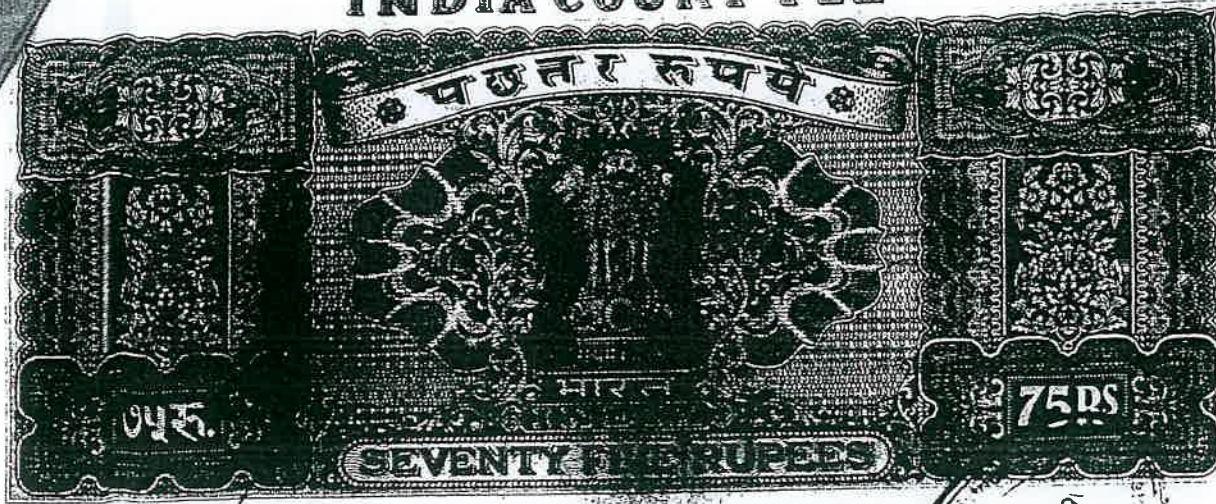

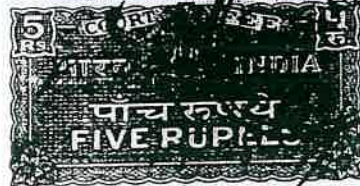

namely Sri Swapan Talukder.

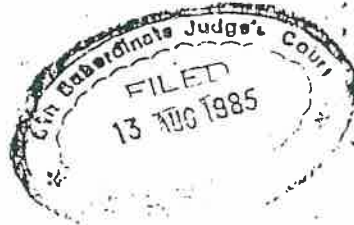
I have another grand daughter, born of my predeceased
