1) SUBEJECT MATTER OF THIS DEED OF GIFT:





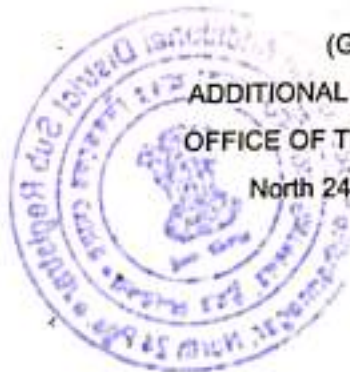
