3. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(Part A and B) were submitted to the Ministry for an appraisal by the State Environment Impact Assessment Authority (SEIAA) in the Ministry under the provision of EIA notification 2006 and its subsequent amendments.

4. The above-mentioned proposal has been considered by State Environment Impact Assessment Authority (SEIAA) in the meeting held on 21/11/2025. The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

5. The brief details of the project are as follows :

This is a proposal for Modification and Expansion of Residential Complex comprising of Residential Block A of G+31 storied and Multipurpose Block B of G+1 storied at 33A/3, Canal South Road, Ward No. 57 of KMC, Borough VII, PS – Tangra, Kolkata – 700 015, West Bengal by M/s. Spring City Buildtech LLP. The total built-up area of the proposed project is 39726.332 sqm. (after expansion). Total land area is 10465.634 Sqm. (after expansion). Total no. of flats 94 nos.

The project proponent has already obtained Environmental Clearance from the SEIAA, WB vide EC Identification No. EC24C3801WB5556789N dated 13.03.2025 vide file no. EN/T-II-1/018/2025 for a Built Up Area of 30,550.403 sq.m.

According to the DSS of the PARIVESH portal, the project area does not touch any CRZ, ESZ, PA WII and RFA.

SEIAA approved the EC based on the Building Permit No. 2025070095 dated 23.09.2025 from Kolkata Municipal Corporation (KMC).

6. The State Level Environment Impact Assessment Authority (SEIAA), West Bengal examined the proposal and also perused recommendations of the State Level Expert Appraisal Committee (SEAC). After due consideration of the project proposal, and after considering the recommendations of the State Level Expert Appraisal Committee (SEAC), the State Level Environment Impact Assessment Authority accords Environmental Clearance to the project as per provisions of the EIA notification no. S.O. 1533 (E) dt. 14th September, 2006 of Ministry of Environment & Forests, GOI and the subsequent amendments, in supers session of EC issued vide EC Identification No. EC24C3801WB5556789N dated 13.03.2025 vide file no. EN/T-II-1/018/2025 on the basis of above mentioned features along with other details submitted to SEIAA subject to strict compliance of the terms and conditions as given in Annexure (1)
7. The Ministry reserves the right to stipulate additional conditions, if found necessary.
8. The EC to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.
9. The Project Proponent is under obligation to implement commitments made in the Environment Management Plan, which forms part of this EC.
10. Validity of EC is 10 years (for construction). Validity of EC becomes perpetual (operational validity) subject to the start of production operations by the project or activity within validity date for construction. In case the project proponent fails to start the production operations within the EC validity date, application for EC validity extension shall be submitted to the regulatory authority as per the provision contained in the EIA notification, 2006 and its amendment.
11. General Instructions:
 - (a) The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of MoEF&CC/SEIAA website where it is displayed.
 - (b) The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt.
 - (c) The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.

(d) Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.

(e) Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.

(f) The Regional Office of this Ministry / SEIAA shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office/ SEIAA by furnishing the requisite data / information/monitoring reports.

(g) Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

12. This issues with the approval of the Competent Authority.

The project proponent shall obtain all necessary clearance/ permission from all relevant agencies including town planning authority before commencement of work. All the construction shall be done in accordance with the local building byelaws.</p> <p>ii. The approval of the Competent Authority shall be obtained for structural safety of buildings due to earthquakes, adequacy of firefighting equipment etc. as per National Building Code including protection measures from lightning etc.</p> <p>iii. The project proponent shall obtain forest clearance under the provisions of Forest (Conservation) Act, 1986, in case of the diversion of forest land for non-forest purpose involved in the project.</p> <p>iv. The project proponent shall obtain clearance from the National Board for Wildlife, if applicable.</p> <p>v. The project proponent shall obtain Consent to Establish / Operate under the provisions of Air (Prevention & Control of Pollution) Act, 1981 and the Water (Prevention & Control of Pollution) Act, 1974 from the concerned State Pollution Control Board/ Committee.</p> <p>vi. WBPCB is requested not to issue Consent to Operate (CTO) till the project proponent obtains necessary land conversion for the entire project area.</p> <p>II. Air quality monitoring and preservation</p> <p>i. Notification GSR 94(E) dated 25.01.2018 of MoEF&CC regarding Mandatory Implementation of Dust Mitigation Measures for Construction and Demolition Activities for projects requiring Environmental Clearance shall be complied with.</p> <p>ii. A management plan shall be drawn up and implemented to contain the current exceedance in ambient air quality at the site.</p> <p>iii. The project proponent shall install system to carryout Ambient Air Quality monitoring for common/criterion parameters relevant to the main pollutants released (e.g. PM10 and PM25) covering upwind and downwind directions during the construction period. 
