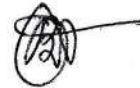

04. CAPITAL AND FUNDS: -

THAT the First Party is invested the sum of Rs.75,000/- and the Second Party is invested the sum of Rs.25,000/- as capital of the partnership business shall be contributed both the partners in the following ratio: -

- (f) All incidental matters in connection with above with any authority on firm's behalf.
- (g) To compromise or settle any dues to the partnership and grant discharge therefore.
- (II) That the partners shall be entitled to carry on business of similar nature either as proprietorship concern or in partnership with others or in any other manner, whatsoever, without any objection of other partner/s.
- (III) That the partners shall be just and faithful to each other and shall work for the best interest of the partnership business.

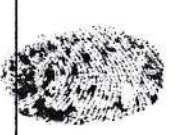
