Compromise cases to withdraw money in Deposit in any Court or Revenue Offices, State Banks or any other Banks or Post Offices, and in fact to do ALL that may be necessary for proper conduct of cases and proceedings on my behalf. I also authorise each of them jointly or singly to settle lands with tenants by fixing rents, to sell lands and buildings on my *behalf* to sign and execute all deeds of transfer in my name to present the said documents for and on my behalf ^{for} Registration before the appropriate Registering Authority in any Registration offices and to admit execution of the same and to get them registered.

83 TO appoint Attorneys to act for me, I moreover, authorise each of my ATTORNEYS jointly or singly to collect rent and money due to my Estate by granting receipts, to file claims on land Acquisition Cases or Calcutta Improvement Trust Offices to withdraw money from any Banks, Land Acquisition Courts and any Post Offices and from any Court of Law and office.

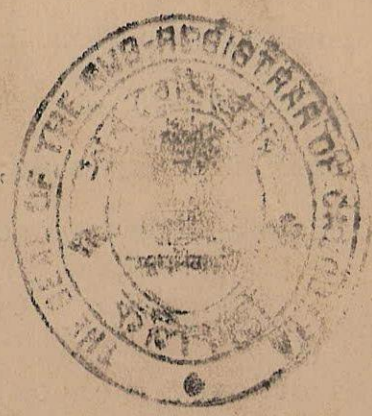
