Hena Ghosh (now deceased), wife of Late Nani Gopal Ghosh, was the absolute owner in possession of all that piece or parcel of land measuring 5.5 Decimal or 03 Katha 06 Chhatak, recorded in R.S Plot No. 309 (P) under R.S Khatian No. 29 being in E/P No. 76(P), situated within Mouza - Ujanu, Pargana - Patharghata, J.L. No. 86, Police Station - Matigara now Pradhan Nagar, Dist. Darjeeling, in the State of West Bengal by virtue of a registered Deed of Gift/Patta being Document No. I-1078 for the year 2005, recorded in Book No. I, Volume No. I, Pages from 5204 to 5207, which was duly executed by Additional District Magistrate of Siliguri on behalf of the Refugee Relief and Rehabilitation Department of Government of West Bengal and the same was registered at the office of the Additional District Sub Registrar at Siliguri, District Darjeeling. executed by Additional District Magistrate of Siliguri on behalf of the Refugee Relief and Rehabilitation Department of Government of West Bengal and the same, was registered at the office of the Additional District Sub Registrar at Siliguri, District- Darjeeling, subsequently Record of Rights was prepared in favour of Smt. Supriti Majumdar, wife of Shri Bimal Kumar Majumdar, in respect of her land measuring 3.3 Decimal or 02 Katha and she obtained a new L.R. Khatian being No. 1280 under L.R. Plot No. 685 which was issued by the concerned office of the B.L & L.R.O Matigara at Shivmandir, Dist. Darjeeling.

- IV. Smt. Supriti Majumdar, daughter of Late Nani Gopal Ghosh and Late Hena Ghosh, by virtue of the above mentioned two separated registered Deeds being Nos. (i) Deed of Gift (Patta) No. I-18 for the year 2009, consisting of land measuring 3.3 Decimal or 02 Katha and (ii) Deed of Gift No. 1-7100 for the year 2022, consisting of land measuring 5.5 Decimal or 03 Katha 06 Chhatak, became the sole, absolute and exclusive owner of all that piece and parcel of total land measuring (02 Katha + 03 Katha 06 Chhatak) = 05 Katha 06 Chhatak or 8.80 Decimal, appertaining to and forming part of R.S Plot No. 309 (P) corresponding to L.R.
