- Permission for conversion will stand revoked - if there is any - violation of the prevailing laws-enforcing prevention-of environmental pollution affecting the land in general of the locality at any point of time.
- Permission-of conversion will also stand -revoked if the land is used other than the purpose for which permission is given.
- The land revenue shall be determined as per sec. 23 of amended WBLR Act.
