

WHEREAS one Harendra Nath Singha granted lease of the land measuring 10 Kathahs to one Shreesha Chandra Kundu by virtue of a Registered Deed of Sale which was registered in the Siliguri Sub-Registry Office and entered in the Book No.1, Volume No.12, Pages 102 to 103 for the year of 1948.



WHEREAS before the last Survey Settlement Operation said Shreesha Chandra Kundu died leaving behind his three sons, namely, Ajit Kumar Kundu, Ranjit Kumar Kundu and Indrajit Kumar Kundu as his only legal heirs.

WHEREAS during the last Survey Settlement Operation the said 10 Kattah of land had been recorded in the names of the aforesaid three legal heirs of the deceased Shreesha Chandra Kundu as the owner of the said 10 Kathah of land each having 1/3 rd. share under the Provisions of West Bengal Estate Acquisition Act. As such the said land has been recorded under Khatian no.4992 bearing Plot No.10264 of Mouza Siliguri, J.L.No.110, Police Station Siliguri, Touzi No.3 Ja.

WHEREAS said Ajit Kumar Kundu purchased the land measuring 2 Kattahs or .03 decimal land which is described in the schedule 'B' below from one Manjusri Sarkar by virtue of a registered Deed of Sale which was registered in the Joint Sub-Registry Office and entered in the Book No.I, Volume No.30, Pages 151 to 156, Being No.2685 for the year of 1981.

WHEREAS said Ajit Kumar Kundu died on 11.2.86 at Siliguri leaving behind the Donors and the Donees as his only legal heirs. 
