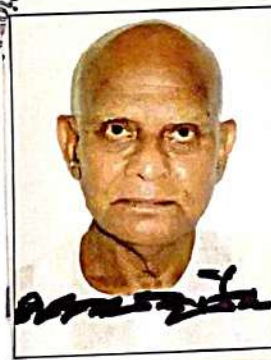

- G. The said Hemnath Sen, had died intestate on 11<sup>th</sup> December 1910 leaving behind him surviving his three sons, namely, Sachindranath Sen, Sudhindranath Sen and Satyendranath Sen as his legal heirs and representatives. His wife Sarodasundari Sen died intestate on 16<sup>th</sup> April 1950.
- H. Thus, in accordance with the said Will of Late Bhabanath Sen, the legal heirs of the said Hemnath Sen i.e. the said Sachindranath Sen, Sudhindranath Sen and Satyendranath Sen collectively became entitled to **ALL THAT** the undivided

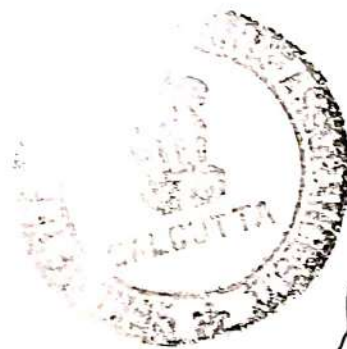

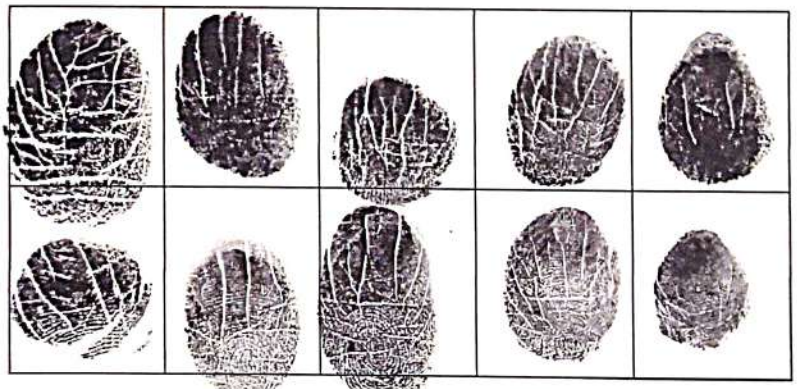

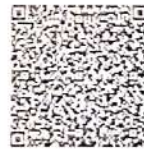
