HIGH COURT ONIGHNAL SIDE

THIS IS THE LAST WILL AND TESTAMENT Of me DINABANDHU SEN Solicitor of No.49, Ramkanta Bose Street formerly of No.44, Ramkanta Bose Street, Calcutta.

I revoke all former wills and Codicils made by me.

I appoint my wife SM, PHUL RANI SEN and my sons AMAL - KUMAR SEN and SHYAMAL KUMAR SEN Executors and Trustees of my - will.

I have two sons one married and the other unmarried and one unmarried daughter Sm. Aparajita Sen also known as SHYAMALI SEN I direct that my Executors and Trustees should spend such sums as they would consider proper and necessary to meet expenses of the marriage of my said daughter Shyamali Sen. My wife if she survives me at the time of the marriage of
my said daughter her decision in the matter of expenses of the
said marriage will be final. If my wife dies before the -marriage of my said daughter the decision of my said two sons
regarding expenses of marriage of my said daughter will be -final. I am sure that they will not differ in their opinion -and they will take more interest in the welfare of my daughter
after my death. My eldest son Amal Kumar Sen is now well -placed in life and I expect that he will take particular -interest in the welfare of my daughter i.e. his only sister.

I, direct that my eldest son Amal Kumar Sen will pay Rs.25/- (Rupees twentyfive) per month to my daughter during her life and my youngest son Shyemal Kumar Sen will pay Rs.15/(Rupees -

(Rupees fifteen) per month to my said daughter during her life.

If any of my said sons desire to pay more they are at liberty
to pay same.

I declare that my wife Sm. Phul Rami Sen shall have the use and enjoyment of my half share in the premises No.49, Ram-kanta Bose Street, Calcutta or of such portion thereof as my sons Amal Kumar Sen and Shyamal Kumar Sen think reasonable for the purpose of her residence during her life time free from any liability for payment of rent rates and taxes and the expenses of repairs. The premises No.49, Ram Kanta Bose Street may be sold if necessary with the consent of my wife Sm. Phulrani Sen. In that case Amal Kumar Sen and Shayamal Kumar Sen will make suitable arrangement for my wife so that she may live there peacefully.

As there is very Condial relationship between my wife - and my sons and I am sure that there will not be any dispute - between them at any time during their respective lives and my sons will look after my wife during her life time.

I therefore direct that my wife and my daughter will not have any interest in any of my properties moveable and immoveable subject to the right of residence of my wife as aforesaid. The rest and residue of my property will go absolutely to my two sons equally, subject to monthly payments to my -- daughter as aforesaid.
