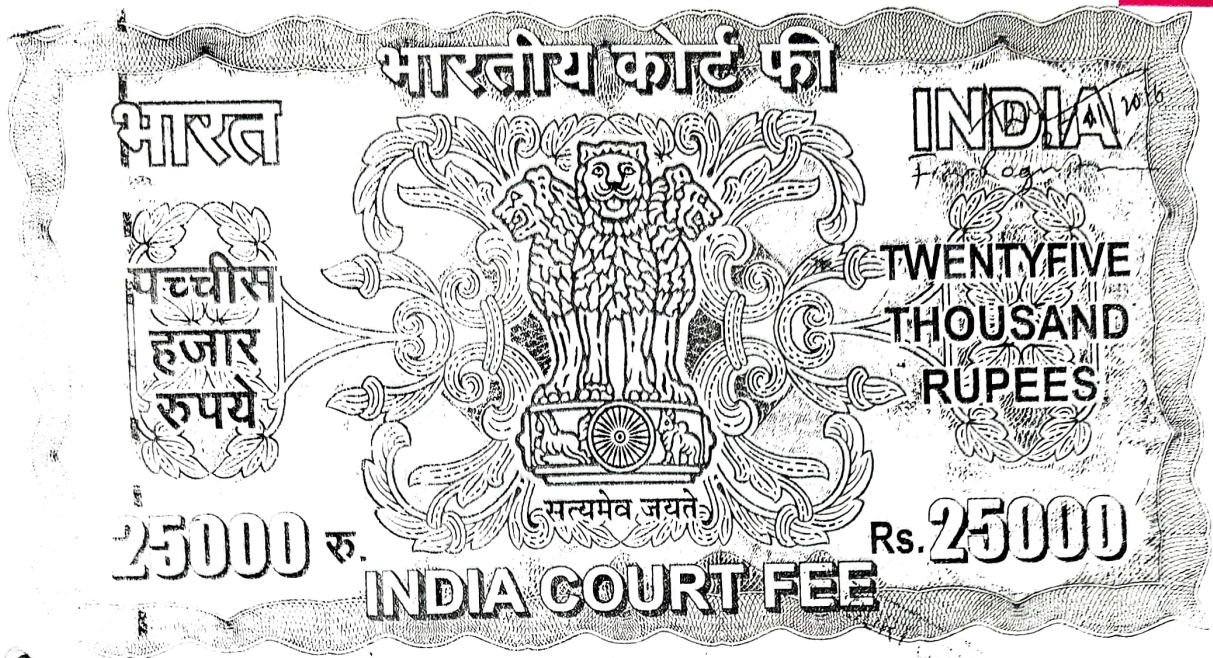

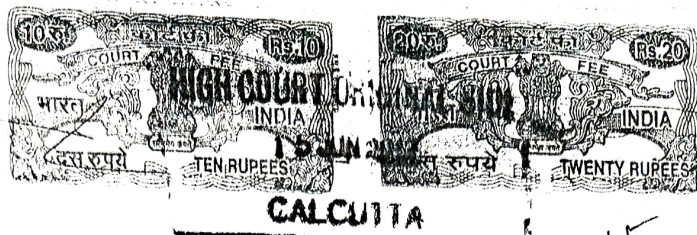

I am, hereby executing this instrument of Will or Last Testament in good health and in sound frame of mind -

My present age is 86 years. I am afflicted by various ailments due to old age, my last days are imminent, as my husband Asrumoy Ghosh had passed....

passed away long back, I have been residing with my late sister, Mala Ghosh's son Sri Shubro Ghosh and his wife, his only son and ^{daughters} ~~daughter~~ 18/9/17 have allowed me to stay with them showing due respect and have been providing and still arranging every thing that are needed by me including those which are necessary for my treatment etc. although my only son Sri Angan Mohan Ghosh's earns enough and he is quite capable but he had or has never looked after me in any manner, and he had declined to take my responsibility. I have become sick at different point of time, even after being informed by my sister's son Shubro Ghosh about my illness, he had declined to take any responsibility of mine in any manner and my....

my sister's son and his wife and his children have taken enough care of me and my sister's son Subhro Ghosh has even borne the huge expenditure of my medical treatment and consultation with renowned doctors including all the times I was admitted in the nursing home due to my illness. and he had requested my son several times to come and visit me, on being requested to come several times by my sister's son Subhro Ghosh, my son Angan Mohan Ghosh casually came to meet me once in the nursing home and went away, but he

had shown no concern of taking the responsibility of my treatment in any manner or do his duty as a son towards....

towards his old mother, which gives
me lot of mental pain all the time.
I am very much aggrieved with my
son, my sister's son Subhro Ghosh,
despite being seriously ill himself,
had taken responsibility of mine
and performed his duty towards
me like his own family, his wife
and children also take my care
all the time like my own son and
daughter-in-law and grand
children which has helped me to
mitigate the pain caused by my
son's negligent and indifferent
behaviour towards me. My said
sister's son Subhro Ghosh, had
undergone by pass surgery twice,
due to his illness he had resigned
from his work, but he and his
family have never been negligent
in taking my responsibility or in
performing....

performing their duties towards me. My said sister's son and his family have been looking after me for the last 26 years and because of their care, I am still leading a normal life. As I am ageing in the natural process and due to my mental pain, I feel that my life is ebbing, I know that my son had never performed his duty towards me and in future also will not do so, that is the reason why I am depriving him in my full senses from the right of performing my last rites after my demise and give my sister's son Subhro Ghosh, the right to perform my last rites after my demise according to his own capacity and desire and as a token of love, affection and blessing towards him and his family, I hereby appoint my sister's son Subhro Ghosh as my sole heir and he shall get after my death the share of my paternal property

receivable by me in premises no. 44, Ramakanta Bose Street, Kolkata-700003, being 79% approximately or (267 Sq. ft.) or such equivalent amount, which-ever will be there and to that my son Arjan Mohan Ghosh shall have no claim or contention and if it is raised then that shall be treated as illegal and shall be liable to be cancelled. Be it known that prior to this I have not executed any instrument of Will or had made any arrangement regarding my aforesaid property mentioned below, this is my first and final Will or last testament, if after my death, if any Will comes to light in this connection then that shall be deemed to be false and shall be treated as cancelled in all courts of law and in every manner.
