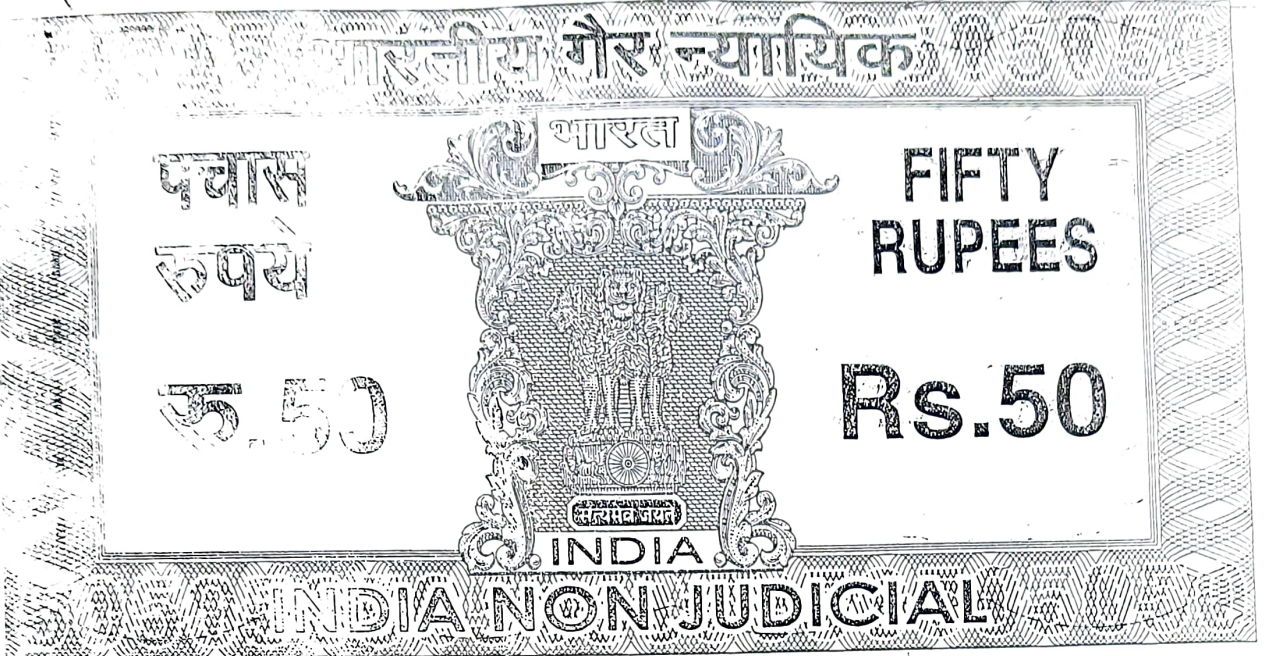

KALPANA DEOGHARIA, W/o. Late Pashupati Deogharia, by faith Hindu, by occupation Business, citizenship Indian, resident of Begunia, P.O. Barakar, Police Station Kulti, District Burdwan, as my true and lawful Attorney to do and perform and / or cause to be done or performed the following acts, deeds and things for me and on my behalf in respect of 1/3rd share of the property left by my deceased father Pashupati Deogharia, more fully mentioned in the schedule below.

WHEREAS my father Pashupati Deogharia (since deceased) is the owner of the moveable & immovable properties mentioned and described in Item No.1 (One) & Item No.2 (Two) of the schedule below. My father died intestate on 01.09.2011 leaving behind him my mother, my elder sister namely Manisha Deogharia and myself as his only legal heirs and we jointly inherited the moveable & immovable properties left by my father according to Hindu Succession Act, 1956, in which I have 1/3rd share, more fully mentioned and described in the schedule below.

AND WHEREAS I am a Service holder and now posted at Hyderabad and it is not at all possible for me to look after the said properties personally and as such by executing this Deed I do hereby appoint, nominate and constitute my mother as my lawful attorney to exercise the following powers conferred upon her for me and on my behalf.

NOW THIS DEED WITNESSETH AS FOLLOWS :-

1. To look after, manage and supervise the schedule mentioned property and to take all appropriate steps for preserving my right, title and interest over the said schedule mentioned property for me and on my behalf.
2. To represent me before all officials and departments of State Govt. and Central Govt. and in all other public and private offices, Nationalised Banks, Private Banks, Financial Institutions, Municipal Offices and to submit all petitions, returns, plans and statements/applications for me and on my behalf relating to the schedule mentioned property.
3. To file all suits, claims and other legal proceedings in all courts, civil, criminal, revenue and other statutory and tribunals for me and to pursue all such legal proceedings by executing necessary vokatnamas and other powers for me and on my behalf and to file Succession Case for collection of debts, dues, securities stands in the credit of my deceased father Pashupati Deogharia, motions, revisions, appeals, writ petitions and writ appeals against all judgements, orders and decrees which may be passed by all such court and judicial and quasi judicial authorities in appropriate higher court or courts and in the writ courts and to defend me in like manner against all suits, cases, legal proceedings, revisions, motions, appeals etc. which may be brought against me in connection with 1/3rd share of the schedule mentioned property belonging to me.
4. To enter into any agreement or contract with any person for selling / creating lease transferring the said property to such party or parties and on such terms as my said Attorney may deem fit and in this connection my said Attorney will be competent to sign and execute all agreements relating to such transfer / lease by receiving consideration price and / or advance price for me and on my behalf.

5. To sign and swear affidavit before the court of law as and when required for me and on my behalf in connection with the said property.

To sign and execute all Sale Deed/s transferring and selling my shares in the schedule mentioned property, in favour of the transferee or transferees on receipt of consideration which may be mentioned in all such Sale Deeds for me and on my behalf and to present all such Sale Deed or Deeds before the appropriate Registering Authority for getting the same registered for me and on my behalf and in this connection my said Attorney shall also be competent to sign all other relevant papers and documents at registration office for me and on my behalf which will be required for the purpose of completing the sale.
