- C. The said mistakes could not be detected and/or noticed by either of the parties till the time of execution and registration of the said Development Agreement. The said mistakes have now been identified and/or come to the knowledge of the parties hereto. The said mistakes have now been agreed to be rectified and/or amended by and between the parties hereto and thereto also, by and under these presents.

NOW THIS DEED WITNESSETH that the following mistakes in the said Development Agreement have been agreed to be rectified and corrected by and between the parties hereto in the following manner:

- At page 8 of the said Development Agreement, in the third line of paragraph No.
  13, "Rs. 50,00,000/- (Rupees fifty lacs)", shall be replaced with "Rs. 1,00,00,000/(Rupees one crore)". Hence, "Rs. 1,00,00,000/- (Rupees one crore)" shall be deleted and "Rs. 50,00,000/- (Rupees fifty lacs)", shall be replaced.

1,00,00,000/- (Rupees one crore)". Hence, "Rs. 1,00,00,000/- (Rupees one crore)" shall be deleted and "Rs. 50,00,000/- (Rupees fifty lacs)", shall be replaced.






