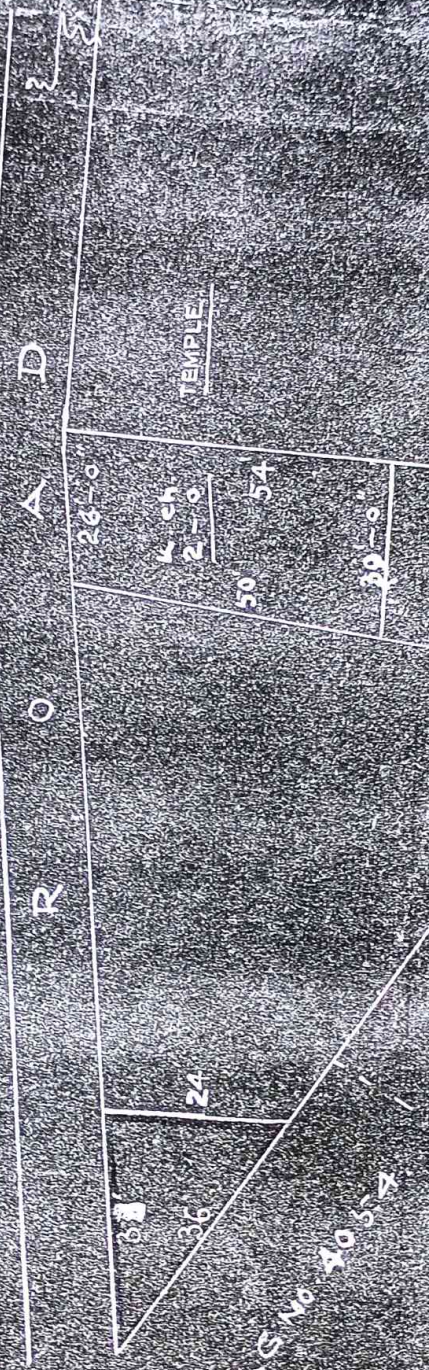
SITE PLAN OF LAND
