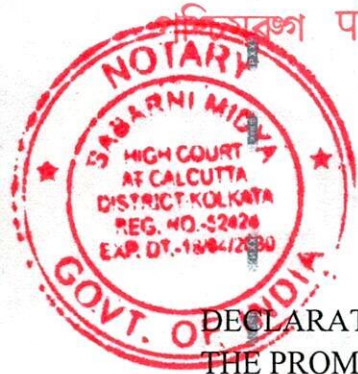

3. That, the Promoter has taken all the pending approvals on time from the competent authorities.

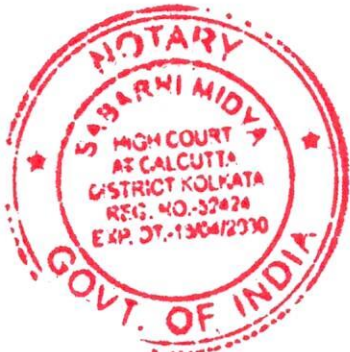
4. That, The Promoter has furnished all other documents as have been prescribed by the rules and regulations made under the Act.
