

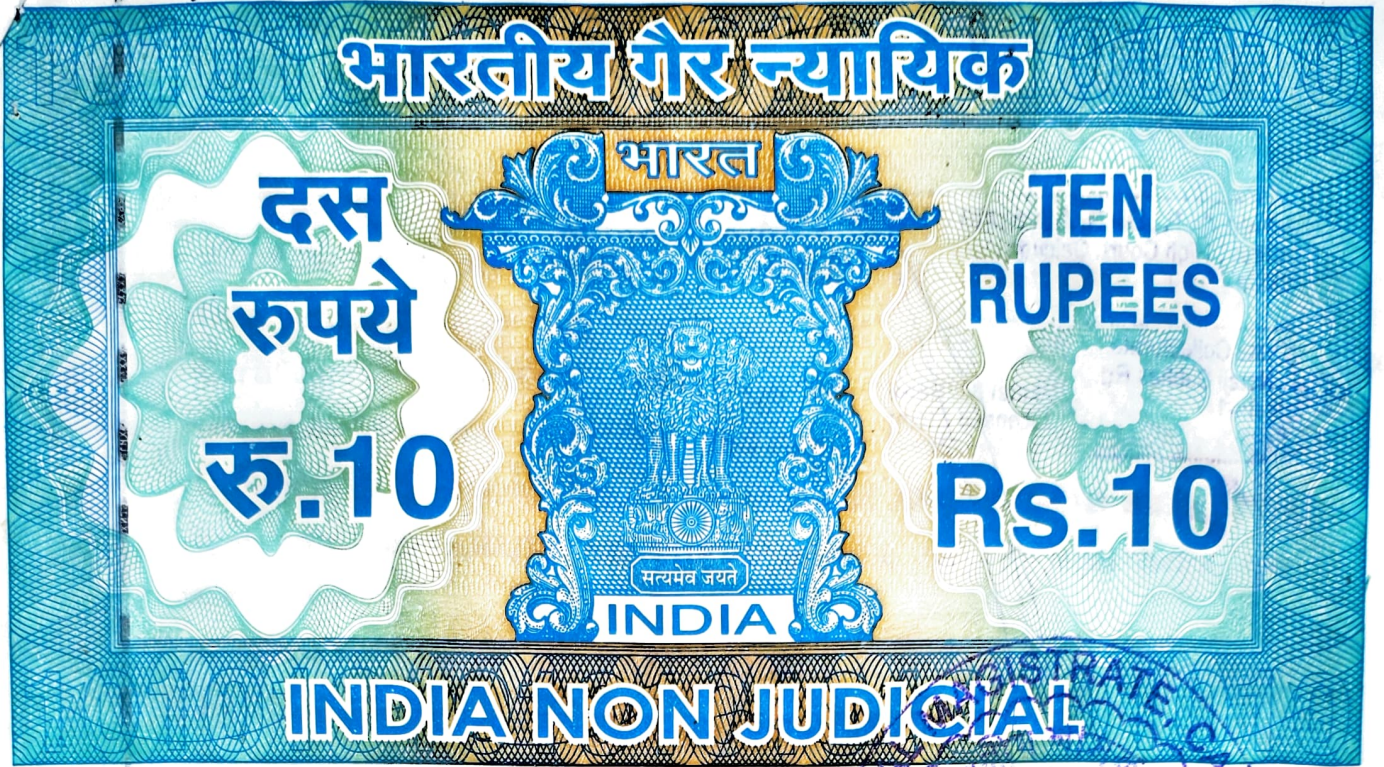



5. That there is no other legal heir left by **LAKSHMI SENGUPTA** and **ANUP KUMAR SENGUPTA** except myself.

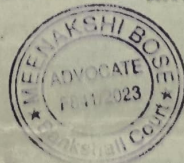
