## SIGNIFICANT ACCOUNTING POLICIES AND NOTES ON ACCOUNTS FORMING PART OF THE ACCOUNTS FOR THE YEAR 2022-23

- The Assessee is following mercantile system of accounting with historical cost convention and all fundamental accounting assumptions have been followed by assesse while preparing books of accounts.
- 2. The Assessee has valued inventory at cost adopting FIFO basis of valuation.
- 3. There is no change in accounting policies, adopted in preparing books of accounts.
- 4. Depreciation on fixed assets has been provided on Written Down Value method.
- 5. No Disclosure of prior period and extra ordinary items have been made separately in the profit and loss account and no material transaction took place during the year.
- 6. Revenue recognition is postponed to a later date only, when it is possible to estimate it with reasonable accuracy.
- 7. Sundry Debtors and Sundry Creditors are subject to confirmation and reconciliation, if any.
- 8. The Assessee has provided for all known committed liabilities. However small items of expenditures, which are not material, have not been provided for as they accounted at time of actual payment.
- 9. Previous year's figures rearranged/ regrouped wherever considered necessary.
- 10. Fixed Assets are capitalized at cost inclusive of expenses on acquisition.
- 11. Wherever expenses are not adequately supported, considering the practice prevailing in trade and nature of expenses has been accepted as properly incurred.
