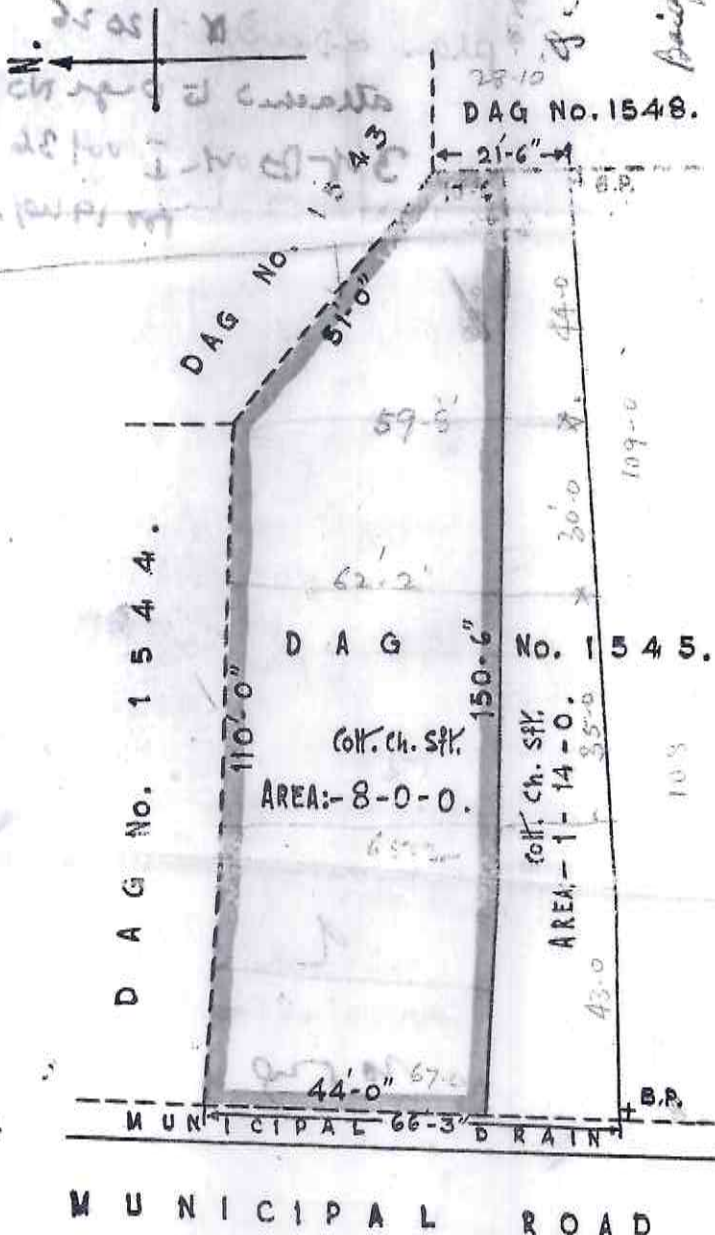
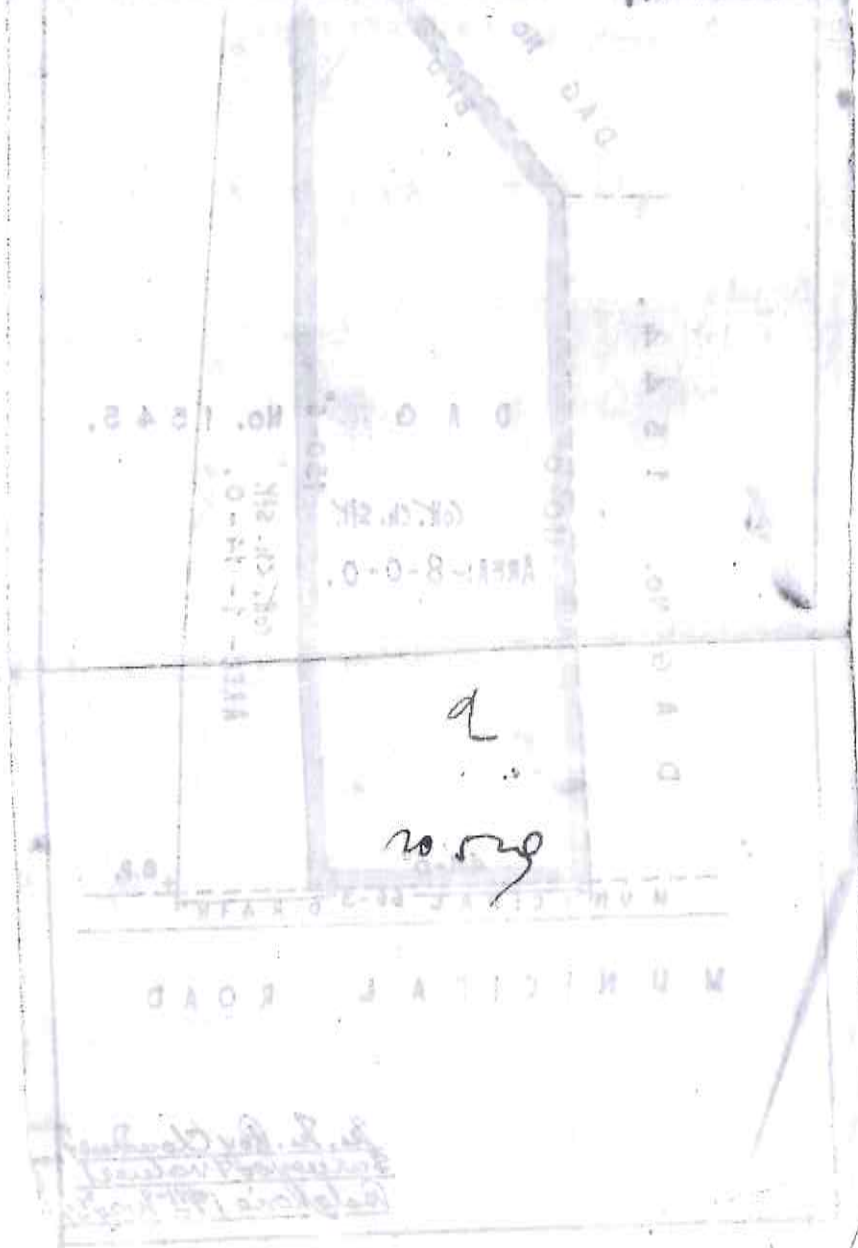


PLAN OF LAND AT BELGHORIA PORTION OF DAG 1543

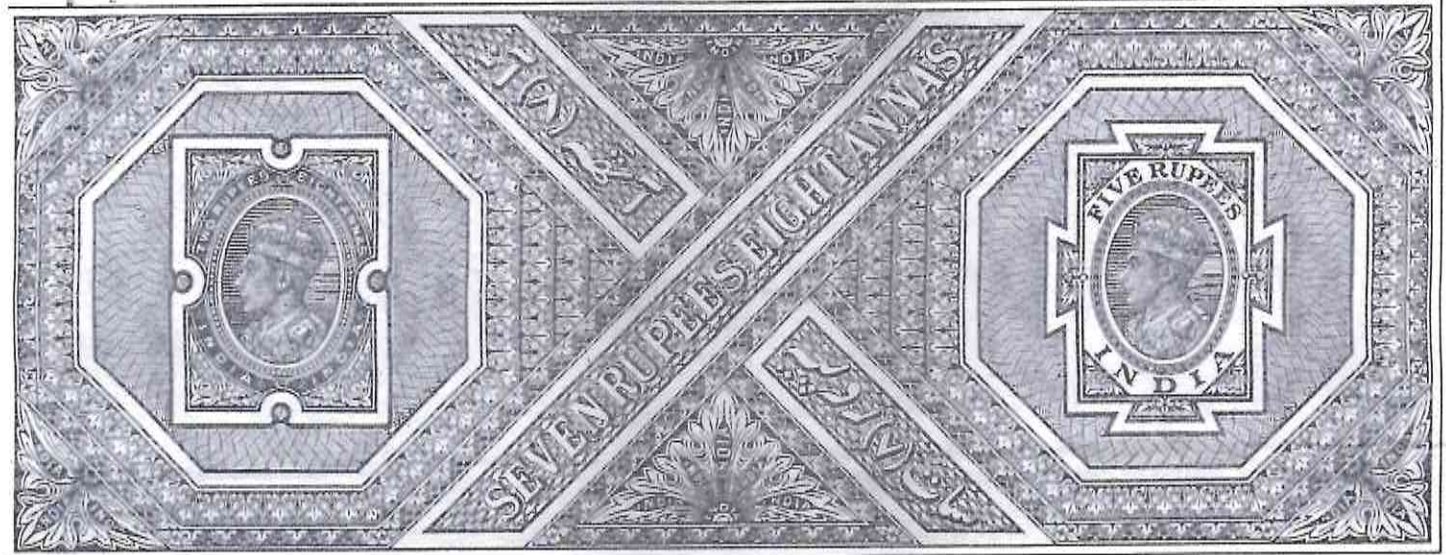
