

13. DUTIES OF PARTNERS : a) All partner shall handover immediately to the firm all the moneys and cheques that may be received by him on account of partnership business.

b) That all partner shall be just and faithful to other partner and at all time give to other partner full information and time explanation of all matters relating to the affairs of the partnership business and afford every assistance to his power in carrying on the business.
