The said suit ended in compromise on 24.03.1980 and on such compromise the land of Sub-plot no.1 of plot no. 223/364 is allotted in my share and sub-plot no. 3 of plot no. 223/364 was allotted to Sm. Puspalata Chowdhury, who sold the same to Shri Tapan Kumar De by regular deed of sale executed on 09/06/1980 and registered as deed no. 3294 for the year -1980 who had subsequently transferred the same to me by virtue of a #deed of sale executed on 22.04.1987 and registered as

registered as deed no.2586 for the year 1987 and the sub-plot no.-5 of Plot no. 223/364 was allotted to Sm.Parul Rani Das who by a sale deed executed on 14.08.1987 and registered as deed no.5346 for the year 1987 has transferred the same to me. Thereby I have become the absolute owner of the said Sub-Plot nos. 1, 3 & 5 of plot no. 223/364 of Mouza :Rangamati,J.L. no.-150,Thana: Medinipur,District :Midnapore,which is sufficiently described in the schedule below and the Map No. 1 annexed to and is made part of this WILL.On the aforesaid Sub-plot nos.1 & 3, I have constructed a dwelling house and well and a bath-room and said sub-plot no.-5 is an open space attached to the constructions as stated above, the details of which are given in Map No.-2 annexed to and is made part of this deed.

I have my wife Sm. Mohon Bala De and five sons namely-(1) Shri
Tapan Kumar De,(2) Shri Swapan Kumar De,(3) Shri Anjan Kumar De,
(4) Shri Chandan Kumar De and (* 5) Shri Ranjan Kumar De and
no daughter.

All my said five sons are well established in their lives.

Myself and my said wife Sm. Mohon Bala De have both become verymuch old and infirm. With a view to avoid future complications and for fulfilment of my desire, I hereby express my WILL and desire that amongst myself and my wife, if unfortunately ,my wife predeceases me, all my immovable properties as per schedule below will go to all my sons as per my detailed prescription hereunder and they will also use to own and possess the immovable properties immediately after my death. They will take possession of my movable properties left after mex me, amicably amongst themselves also immediately after my death.

If however, I predecease my said wife Sm. Mohon Bala De, then my said entire immovable properties as detailed in the Schedule below and all my movable properties shall be owned and possessed exclusively by my said wife save and except the share of my son Shri Anjan Kumar De, (open space in Sub-plot no.-5 of plot no. 223/364 -(item nos. (e) and (g) below and as referred to in map nos.1 & 2) who will own and possess it immediately after my death but before my wife, and after her death only, the properties as detailed against items (a) to (d) and (f) to (g) and in the schedule below and more particularly drawn and described in the Map no.1 and Map No.-2 shall be distributed and owned and possessed by my remaining four sons namely, Shri Tapan Kumar De, Shri Swapan Kumar De, Shri Chandan Kumar De and Shri Ranjan Kumar De according to my prescription as detailed hereunder:-

- d) The land and constructions as shown in the Map no.-2 by letter 'D' shall go to and shall be owned and possessed by my son Shri Ranjan Kumar De.
- e) The land(open space) as shown in the Map No.-2 by letter

- by letter 'G' shall be used by all my five sons jointly and in common but my four sons namely Shri Tapan Kumar De, Shri Swapan Kumar De, Shri Chandan Kumar De and Shri Ranjan Kumar De shall be in absolute title and possession and my son Shri Anjan Kumar De shall be on permissive possession provided that the proposed garrage and the proposed drain as x drawn up in Map no.-2 may be constructed by my said four sons and my son Shri Anjan Kumar De shall be in permissive possession thereon on appropriate contribution towards the constructions.

The WILL is absolutely in respect of the properties as detailed in the annexed Map.No.-1 and Map No. -2 and not in respect of any other immovable properties of myself which may be left at my death.

The 5(five) sons of mine as detailed above shall also include their respective heirs, legal representatives administrators and assigns.

No WILL has been executed by me before, if there be any, then the same shall be treated to be cancelled and this WILL shall be treated as my last and final WILL.

I hereby appoint all my said five sons jointly and severally as the executors /executor of this WILL.
