3. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(Part A and B) were submitted to the Ministry for an appraisal by the State Environment Impact Assessment Authority (SEIAA) under the provision of EIA notification 2006 and its subsequent amendments.

4. The above-mentioned proposal has been considered by State Environment Impact Assessment Authority (SEIAA) in the meeting held on 24/02/2026. The minutes of the meeting and all the application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

5. The brief details of the project are as follows :-

This is a proposal for Residential cum Commercial complex having 3 Residential blocks - Block 1A, 1B, 1C – G+18 storied, 1 Podium block – car parking - G+3 storied and 1 commercial Block – 2B+G+2 storied at Holding no.- 224F, B.T Road, under Panihati Municipality, Ward no – 14, Mouza – Sukhchar, J.L. no – 09, R.S. Khatian no – 115 - 118, 2016, 2017, R.S Dag no – 3408 - 3412, 3417 - 3419, 3408/3529, 3419/3557 & 3483, Now L.R. Khatian no. – 2676, L.R. Plot no. – 9511, Kolkata – 700115, P.S. – Khardah, West Bengal by **M/s. Sagnik Export (I) Pvt. Limited.**

The total built-up area of the entire project will be 67,150.96 sq.m. and the total land area will be 16296.7 sqm. (as per deed) and 15639.98 sqm. (as per physical measurement). Total no. of flats 370 no.

SEIAA approved the EC based on the Building Permit Number: SWS-OBPAS/2123/2025/0057 dated 29.12.2025 from Panihati Municipality.

6. The State Level Environment Impact Assessment Authority (SEIAA), West Bengal examined the proposal and also perused recommendations of the State Level Expert Appraisal Committee (SEAC). After due consideration of the project proposal, and after considering the recommendations of the State Level Expert Appraisal Committee (SEAC), the State Level Environment Impact Assessment Authority accords Environmental Clearance to the project as per provisions of the EIA notification no. S.O. 1533 (E) dt. 14th September, 2006 of Ministry of Environment & Forests, GOI and the subsequent amendments, on the basis of above mentioned features along with other details submitted to SEIAA subject to strict compliance of the terms and conditions as given in Annexure (1).
7. The Ministry reserves the right to stipulate additional conditions, if found necessary.
8. The EC to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.
9. **Validity of EC is 10 years (for construction). Validity of EC becomes perpetual (operational validity) subject to the start of operations by the project or activity within validity date for construction. In case the project proponent fails to start the production operations within the EC validity date, application for EC validity extension shall be submitted to the regulatory authority as per the provision contained in the EIA notification, 2006 and its amendments.**
10. General Instructions:
  - (a) The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of MoEF&CC / SEIAA website where it is displayed.
  - (b) The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt.
  - (c) The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
  - (d) Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during

operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.

(e) Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.

(f) The Regional Office of this Ministry / SEIAA shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office/ SEIAA by furnishing the requisite data / information/monitoring reports.

(g) Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

11. This issues with the approval of the Competent Authority.

The project proponent shall obtain all necessary clearance/ permission from all relevant agencies including town planning authority before commencement of work. All the construction shall be done in accordance with the local building byelaws.</p> <p>ii. The approval of the Competent Authority shall be obtained for structural safety of buildings due to earthquakes, adequacy of firefighting equipment etc. as per National Building Code including protection measures from lightening etc.</p> <p>iii. The project proponent shall obtain forest clearance under the provisions of Forest (Conservation) Act, 1986, in case of the diversion of forest land for non-forest purpose involved in the project.</p> <p>iv. The project proponent shall obtain clearance from the National Board for Wildlife, if applicable.</p> <p>v. The project proponent shall obtain Consent to Establish / Operate under the provisions of Air (Prevention &amp; Control of Pollution) Act, 1981 and the Water (Prevention &amp; Control of Pollution) Act, 1974 from the concerned State Pollution Control Board/ Committee.</p> <p>vi. <b>The project proponent shall obtain the necessary permission for drawl of ground water /surface water required for the project from the competent authority.</b></p> <p>vii. Air quality monitoring and preservation</b></p> <p>i. <b>Notification GSR 94(E) dated 25.01.2018 of MoEF&amp;CC regarding Mandatory Implementation of Dust Mitigation Measures for Construction and Demolition Activities for projects requiring Environmental Clearance shall be complied with.</b></p> <p>ii. A management plan shall be drawn up and implemented to contain the current exceedance in ambient air quality at the site.</p> <p>iii. <b>The project proponent shall install system to carryout Ambient Air Quality monitoring for common/criterion parameters relevant to the main pollutants released (e.g. PM10 and PM25) covering upwind and downwind directions during the construction period. The ambient air quality monitoring should be done fortnightly during the construction phase for each project and all such reports should be included in the six monthly compliance reports.</b></p> <p>iv. Diesel power generating sets proposed as source of backup power should be of enclosed type and conform to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Use of low sulphur diesel is mandatory. The location of the DG sets may be decided in consultation with State Pollution Control Board.</p> <p>v. <b>Construction site shall be adequately barricaded before the construction begins. Dust, smoke &amp; other air pollution prevention measures shall be provided for the building as well as the site. These measures shall include screens for the building under construction, continuous dust/ wind breaking walls all around the site (at least 3 meters height). Ambient noise levels shall conform to residential area/commercial area/industrial area/silence zone both during day and night as per Noise Pollution (Control and Regulation) Rules, 2000. Incremental pollution loads on the ambient air and noise quality shall be closely monitored during construction phase. Adequate measures shall be made to reduce ambient air and noise level during construction phase, so as to conform to the stipulated standards by CPCB / SPCB.</p> <p>ii. Noise level survey shall be carried out as per the prescribed guidelines and report in this regard shall be submitted to Regional Office of the MoEF&amp;CC along with SEIAA and WBPCB as a part of six-monthly compliance report.</p> <p>iii. 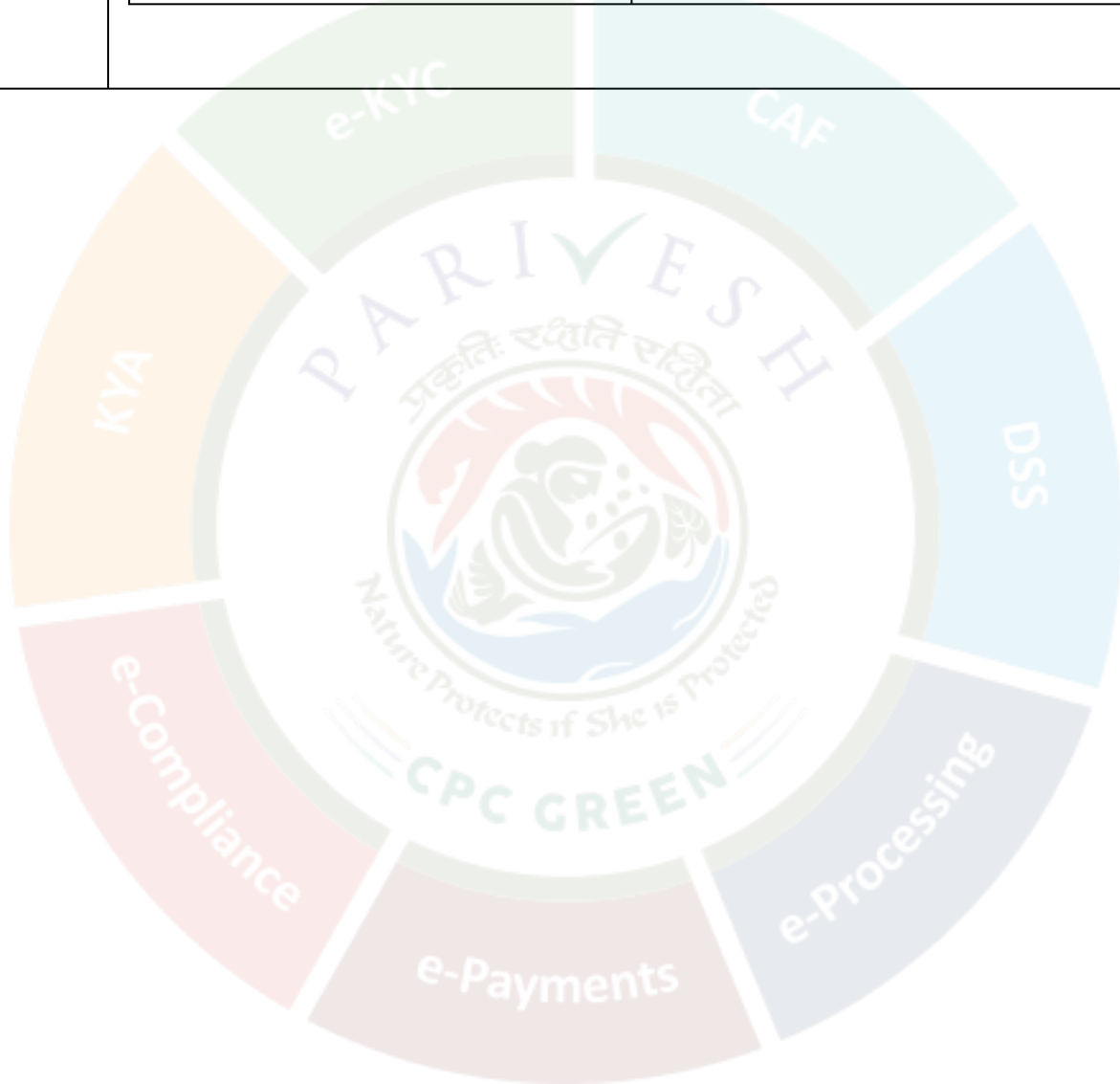

	<p>vi. Any hazardous waste generated during construction phase, shall be disposed off as per applicable rules and norms with necessary approvals of the State Pollution Control Board.</p> <p>vii. Use of environment friendly materials in bricks, blocks and other construction materials, shall be required for at least 20% of the construction material quantity. These include Fly Ash bricks, hollow bricks, AACs, Fly Ash Lime Gypsum blocks, Compressed earth blocks, and other environment friendly materials.</p> <p>viii. Fly ash should be used as building material in the construction as per the provision of Fly Ash Notification of September, 1999 and amended as on 27<sup>th</sup> August, 2003 and 25<sup>th</sup> January, 2016. Ready mixed concrete must be used in building construction.</p> <p>ix.
