

AND WHEREAS the said Lipika Seal, Pijus Roy and Goutom Kumar Roy and Manoj Gopal Roy got their names recorded and/or mutated in the office of the B.L.&L.R.O. concerned in respect of land measuring 17 decimals more or less in L.R.
