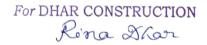

- 3. a. We report the following observations/comments/discrepancies/inconsistencies if any:
 - It was observed that Rina Dhar proprietor of DHAR CONSTRUCTION taken advances for flat booking of Rs.5338000.00 during the financial year 2020-21 from different parties. As per GST provisions, GST should be applicable on advance received by the proprietor for flat booking but for financial year 2020-21 the proprietor has not paid any GST on advance for flat booking except of GST output of Rs.12674.00 on advances for flat booking of Rs.1267326.00 eventhough she had GST registration. So as per our observation the proprietor has not maintain the GST compliance and provisions. It was also observed that Confirmation for Sundry Debtors, Loans Given to ATANU DHAR, KAMANYA ROY, TAMAL ROY, MANJU & SATYAJIT, Advances for Flat Booking, Balance of State Bank of India and Sundry Creditors as on 31st March, 2021 are still not providing to us by the proprietor of the proprietorship concern.
 - b. Subject to above,-
 - A. We have obtained all the information and explanations which, to the best of our knowledge and belief, were necessary for the purposes of the audit.
 - B. In our opinion, proper books of account have been kept by the head office and branches of the assessee so far as appears from our examination of the books.
 - C. In our opinion and to the best of our information and according to the explanations given to us the said accounts, read with notes thereon, if any, give a true and fair view:-
 - i. In the case of the balance sheet, of the state of the affairs of the assessee as at 31st March 2021; and
 - ii. In the case of the profit and loss account, of the Profit of the assessee for the year ended on that date.
