and/or Skill and by agreeing to share the profits as well as the losses of the Firm in the ratio mentioned herein below.

AND

Whereas in order to avoid any future dispute and disagreement it is desirable and advisable to execute a formal instrument of Partnership embodying there in the mutual terms and conditions under which the partnership business is continued.

Now, therefore the above named parties do hereby affirm, declare, confirm and verify having ab-ini-tio settled and agreed as follows:

:- TERMS AND CONDITIONS :-

(1) That the Name of the Firm shall be **"PEACE APPARTMENT"**.

(2) That the Head Office of the Firm which is rented shall be situated at Hatudewan, Katwa Road, Burdwan, P.O. & P.S.- Burdwan, Dist.- Purba Bardhaman, Pin-713101, West Bengal, but it may change its Head Office with mutual consent between the partners. The Branches may be opened at any place at anytime as decided by the Partners from time to time.

(3) That the Firm shall carry on the business of partnership business of promoting and developing of land and sale and purchase of land, decided by the Partners for an unlimited period unless otherwise determined by the Partners and the duration of the partnership will be at will.

(4) That the capital of the Firm shall be contributed by the Partners equally.

(5) That the Profits and Losses of the Firm shall be divided or borne between the Partners equally.

(6) That the Accounting Year of the Firm shall be commenced on the 1st day of April to 31st March each year and the Firm shall be deemed to have commenced on and from **1st Day of January, 2024**.

(7) The firm shall open a bank account in the name of **"PEACE APPARTMENT"** at any bank and such account shall be operated by all partner namely **MAHAMMAD**

ALI SEIKH, SWAPAN HALDER and PRADIP KUMAR MAJUMDER Jointly as declared from time to time to the Banks.

(8) That the written consent of all Partners will be required for the partnership to avail credit facilities from any financial institution.

(9) That all the Partners shall attend diligently to the business of the Partnership and carry on the same for the greatest advantage of the Partners and neither of them shall be directly or indirectly engaged or interested in any business of the same nature except that of Partnership.

(10) That the Salary shall be paid to all the working Partners individually at the ratio mentioned herein below:-

FIRST PARTNER - Rs. 12000/- P.M.

SECOND PARTNER - Rs. 12000/- P.M.

THIRD PARTNER - Rs. 12000/- P.M.

That in the case of poor profit, the Salary to the Partners may be reduced as decided by the Partners time to time. That the payment of Salary shall be made monthly, yearly or any other mode as decided by the Partners.

(11) That the Partners shall be entitled to draw interest on their respective Capital upto 12% at the end of each year.

(12) That the any partner shall be the Managing Partner of the Firm and sign on all documents touching the business of the Firm. That the said Partner will supervise the day to day work of the Firm and will inform other Partner regularly regarding the business affairs of the Partnership Firm.

(13) That all outgoings and expenses in relation to the business of the Firm shall be paid out of the Capital and profits of the business and in the case of deficiency by the Partners in the ratio mentioned herein above.

(14) That all the Partners shall punctually pay and discharge their separate debts and liabilities and shall indemnify and keep indemnified the Firm effectually against the same

(15) That If any partner shall at anytime during the subsistence of the partnership, be desirous of retiring from the firm, it shall be competent from his to do so, provided he shall give at least one clear month notice of his intention of doing so. The remaining partner shall pay to the retiring partner or his legal representatives of the deceased partner, the purchase money of his share in the assets of the firm.

(16) That in case of death of any Partner, the legal heir or heirs of the deceased Partner shall step into the shoes of the deceased Partner. If he/she/they do not choose to become a Partner or Partners in that case the share of Profits and Losses and of the assets after meeting the liabilities of the Firm shall be paid to them within two months from date of such occurrence.

(17) That no Partner shall be entitled to sell, assign relinquish or transfer his share in the Firm to any third person without written consent of the other Partners.

(18) That the terms and conditions of this deed of Partnership may be altered, deleted or any new terms and conditions may be added at anytime as may be decided by the Partners from time to time.

(19) That the usual and proper books of accounts shall be maintained by the Firm under the supervision of all the Partners. Those records shall not be removed from the place of business without genuine requirements of the Firm.

(20) That the General Accounts of the Firm shall be prepared on the last day of each Accounting Year showing the assets and liabilities and the Profits and Losses of the Firm. Such accounts can be reopened only if any error or mistake is discovered within three months from the end of such Accounting Year in the said accounts in which case it shall be rectified forthwith. After the general accounts so signed the net profits and losses shall be allocated to the Partners according to their respective Profit sharing ratio started in cl.(5) of this Deed of Partnership.

(21) That save and except the terms and conditions specifically agreed between the Partners by this Deed or by any subsequent agreement, the Provisions of the Indian Partnership Act, 1932 shall be applied.

(22) That in case of any dispute or difference arising amongst the Partners during the continuance of this Partnership business or afterwards regarding the interpretation of

the contents of this Deed of Partnership or regarding any matter or transaction touching the Partnership business it shall be referred to arbitration in accordance with the provisions of the Indian Arbitration Act, 1940 and decisions under such arbitration shall be final.
