5. That the amount from the separate account , to cover the cost of project shall be withdrawn in proportion to the percentage of completion of the project .
6. That the amount from the separate account , that the withdrawn after its certified by an engineer an architect and a chartered accountant in practice , that the withdrawal is proportion to ,the percentage of completion of the project .
7. The promoter shall get the account audited within six month after the end of every financial year by a chartered accountant in practice and shall produce a statement of account duly certified and signed by such chartered accountant and it shall be verified during the audit that the amount collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion of the percentage completion of the project .
