

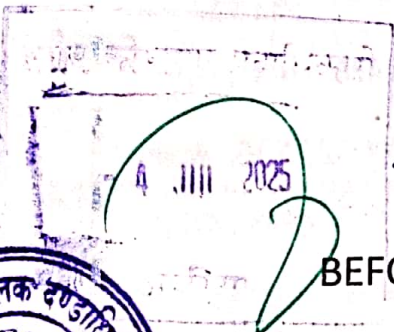

AND WHEREAS the parties of all the parts have now decided to amalgamate their respective plots of land for the better utilisation of the land and to give better shape to the building to be constructed thereon under certain terms and conditions mentioned here-in-under.

AND WHEREAS the parties hereto thought it advisable to reduce the terms and conditions in writing to avoid future disputes and misunderstanding among themselves.

**NOW THIS AGREEMENT WITHSESSETH AS FOLLOWS :**

1. That the parties hereto have agreed to construct a building by amalgamating their individual's plot of land for giving a better shape to the building to be constructed.

2. That the parties hereto shall individually contribute the cost of construction of their own part.

3. That the parties hereto shall be entitled to let - out, lease - out, mortgage and/or transfer their own portion, to whomsoever and also the Parties shall be jointly/collectively entitled to let - out, lease - out, mortgage.

4. That the parties hereto shall be entitled to produce this agreement before the appropriate authority (i.e. at the time of approval of the building plan) as and their required at any time here-in-after.

5. That all the parties shall be submit the building plan jointly/collectively under the supervision of the same engineer.




