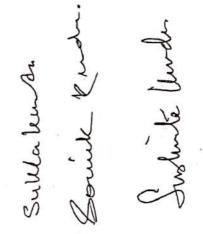

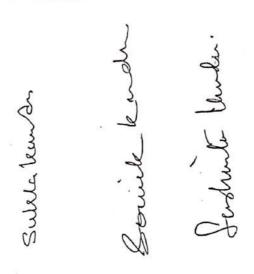

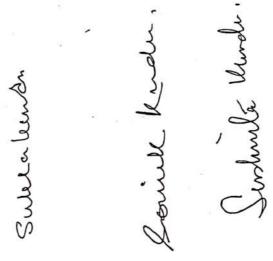

AND WHEREAS the abovenamed Subhas Kundu alias Subhash Kundu, died intestate leaving behind the following three legal heirs namely:-

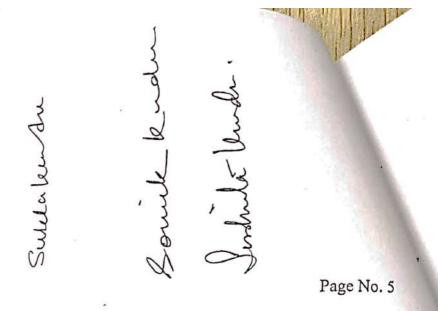
