

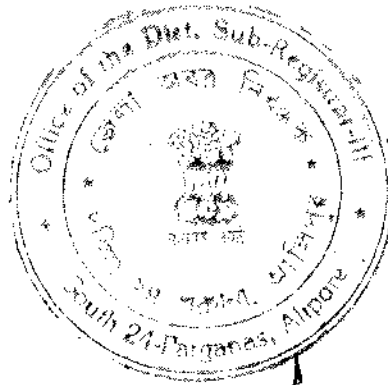



**WHEREAS:**

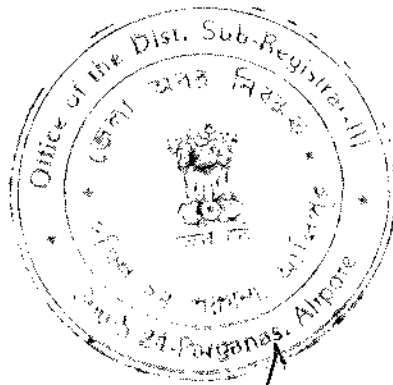

Mouza - Rashpunja, P.S - Bishnupur, District - South 24 Parganas, West Bengal**



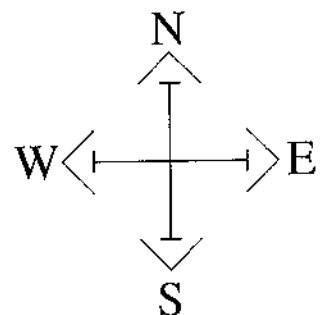
