My sons Mr. Anil Kandoi (Adopted) and Mr. Sanjay Kandoi have been very arrogant, disrespectful and disobedient towards me and my wife and because of this I have not bequeath anything to them. In my lifetime I have already given them which is sufficient.

I Will and Wish that on my demise all my immovable and movable properties should devolve in the following manner:

1. The immovable property no. Khatian No. 1427/1 j) Dag No. 2946 within Pargana : Bai Kunthapur, Mauz: Siliguri J. L. No.110 Under P.S. & P.O. Siliguri. Now known as 4, Agrasen Road, Siliguri shall exclusively devolve on my death to my wife Smt. Bimla Devi Kandoi for her life and then to my eldest son Shri Kailash Kumar Kandoi absolutely, as my elder son has taken very good care of my wife and me. He is one son which every parent would crave for. In case of my son pre-deceases me, the property shall devolve to his surviving heirs.
2. All my shareholding i.e. 25200 (Twenty Five Thousand Two Hundred) Shares in the company i.e. O.P.Kandoi & Company (P) Limited shall go to my elder son Shri Kailash Kumar Kandoi absolutely. In case of my son pre-deceases me, the property shall devolve to his surviving heirs.
