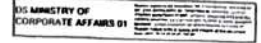

1 The Name of the Company is

3 (a) The objects to be pursued by the company on its incorporation are

1 To carry on business as estate agents and estate managers and to collect rents, repair, look after and manage immovable properties of or for any persons, firms and companies, governments and States, as well as this company, to give, take, let and sublet rent-farming contracts and to carry out, undertake or supervise any building, constructing, altering, improving, demolishing and repairing operations and all other works and operations in connection with immovable estates and properties.

2 To carry on business as house, land and estate agents, and to arrange or undertake the sale, purchase or, advertise for sale or purchase, assist in selling or purchasing and find or introduce purchaser or vendors of and to manage land building and other property whether belonging to the company or not, and to let any portion of any premises for residential, trade or business purposes, or other private or public purposes, and to collect rents, and income and to supply to tenants and occupiers and other refreshment clubs, public halls, messengers, lights, waiting rooms, reading room, meeting rooms, lavatories, laundry conveniences, electric conveniences garages and other advantages.

3 To carry on the trade or business of dealing in and agents for lands, buildings, factories, house, flats and other residential commercial, agricultural and mining properties and construct, maintain and alter residential commercial and industrial plots and properties and give them on lease rent or otherwise.

4 To take lease of buildings, land for business or residential purpose from any person, trust, Government, Company or any organization.

3 (b) Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1 To enter into agreement, arrangement, joint venture, collaboration, syndication, consortium, partnership or any other arrangement with Central Government, State Government, local authority, statutory body, company, firm, individuals and or otherwise with any other person or entity whether for sharing profits or for co-operation or reciprocal concession or for license or otherwise and promoting a new business unit for manufacturing, owning, building, developing, maintaining, operating, also running, leasing, transferring, carrying on or engage in or about to carry on engage in any business or transaction which this Company is authorised to carry or engage in any business or transaction capable of being conducted so as to benefit this Company and to give with any special rights, licenses, and privileges in connection and in particular the right to nominate one or more person or persons, whether they be shareholders or not, of the Company.

2 To buy, sell, process, import, export and deal in apparatus, machinery, tools, stores and spares connected with the main objects and to establish and maintain control rooms for carrying out the work of repairs, developments, improvements or to benefit the Company.

3 To purchase, exchange or otherwise any movable or immovable property and any rights or privileges which the Company may deem necessary or convenient for the purpose of its main business.

4 To act as consultant, adviser, broker, supervisor, administrator, agent, commission agent and to offer various types of incentives, schemes from time to time either directly or in collaboration with any other individuals, firms, bodies corporate in India or elsewhere and to educate people for side work, entertainment and side work personality development.

5. To promote or assist in the promotion of any other Company or Companies established for any purpose which may seem directly or indirectly to benefit this Company or to advance the object and interests thereof, and to take otherwise acquire and hold shares in any such Company or Companies and to guarantee the payment of any debentures or other securities issued by such Company or Companies.
6. To make investments, purchase, subscribe for, underwrite, take acquire and hold, sell, mortgage and deal in share stock, bonds, options debentures, debenture stock or obligations in any other Company or Corporation and to give any guarantee or security for the payment of the dividends or interest thereon or in relation thereto, in matters of interest to the Company.
7. To draw, make, issue, accept and to endorse, discount and negotiate promissory notes, hundies, bills of exchange, bills of lading, delivery orders, warrants, warehousekeeper's certificates and other negotiable or commercial or mercantile instruments connected with the business of the Company.
8. To purchase acquire and undertake all or any part of the business, property goodwill and liabilities of any person or company carrying on any business which this Company is authorized to enter into or carry on, or to possess property suitable for the purpose of this Company.
9. ☐	(i) Every person whose name is entered as a member in the register of members shall be entitled to receive within two months after incorporation, in case of subscribers to the memorandum or after allotment or within one month after the application for the registration of transfer or transmission or within such other period as the conditions of issue shall be provided, - (a) one certificate for all his shares without payment of any charges; or (b) several certificates, each for one or more of his shares, upon payment of twenty rupees for each certificate after the first.
