- That the time period within which the project shall be completed by me/Promoter is 30.04.2025.
- That , seventy per cent of the amounts realized by me/Promoter for the real estate project 4. from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- That , the amounts from the separate account to cover the cost of the project shall be 5. withdrawn in the proportion to the percentage of completion of the project .
- That , the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- That , I/promoter shall get the accounts audited within six months after the end of every 7. financial year by a chartered accountant in practice and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project .
- That , I/promoter shall take all the pending approvals on time from the competent 8. authorities.
- That , I/promoter have / has furnished such other documents as have been prescribed by 9. the rule and regulations made under the Act.
- That , I/promoter shall not discriminate against any allottee at the time of allotment of any 10. apartment, plot or building, as the case may be, on any grounds.
