

2. That the said one of the recorded owners Samir Ghosal Chaudhury died intestate on 04/10/2023 leaving behind and surviving his wife Smt. Nandita Ghoshal Choudhuri and only son Sri Sayandee Ghosal Chaudhury as his heirs, successors and legal representatives as per Hindu Succession Act, 1956 and he had no other heirs, successors and legal representatives at the time of his death save and except the aforementioned persons the present deponents. His father Jyotsna Kumar Ghoshal Chaudhury predeceased him on 28/12/1990 and his mother Renuka Ghoshal Chaudhury predeceased him on 06/06/1993.
3. That after the demise of said one of the recorded owners Samir Ghosal Chaudhury his undivided 1/3rd share of Premises No.39, K.P.Roy Lane, Kolkata-700 078, P.S. Garfa, now within the local limits of The Kolkata Municipal Corporation under Ward No.105, Borough-XII, left by him thus devolved upon ourselves, the present deponents as his heirs, successors and legal representatives as per Hindu Succession Act, 1956 and we jointly inherited and became the joint owners of the said undivided 1/3rd share of the aforesaid property left by our predecessor-in-interest Samir Ghosal Chaudhury.
