7. The construction shall be undertaken as per sanctioned plan only and no deviation from the Kolkata Municipal Corporation Building Rules 2008 shall be permitted. Any deviation from sanctioned plan requires approval of the Kolkata Municipal Corporation Building Rules as to be sanctioned and the supervising Architect License Building Surveyor engaged to the job will stop the work on finding this license cancelled.
8. The set of finally signed plan and other related documents as applicable must electronically.
9. Construction/Structure has water supply arrangement including sewer underground & rain water harvesting should be obtained from water supply department before proceeding with the work of water supply. any deviation may lead to disconnection/penalisation.
10. No rain water pipe should be fixed or discharged on Road or Footpath.
11. An Internal Waste Disposal plan prepared by Licensed Plumber under supervision of LBS Architect

However, in case of developments exceeding total floor area 5000 sq.m which includes construction of S.T.P, rain water harvesting, waste water recycling, air conditioning of building, Construction of fire reservoir and fire pump, civil, mechanical, electrical, solar panel, solar water heater system, lighting arrester system etc, LBS-Architect will engage reputed mechanical, electrical plumbing (M.E.P) consultant who will implement the above works under supervision of LBS-Architect.
13. Copy of this proposal/revision/modification of the plan requires approval before application for Completion.
14. A suitable pump has to be provided i.e. pumping unfiltered water for the distribution to the flushing cisterns and toilets of the building unless unfiltered water from street main is not available.
15. Deviation would mean Demolition.
16. Construction site shall be maintained to prevent mosquito breeding as required s/s 49(1) & (2) of AMC act 1982.
17. Such manner so that all water collection & particularly lift wells, vents, basement curing sites, open receptacles etc. must be emptied completely twice a week.
18. Necessary steps should be taken for the safety of the lives of the adjoining public and private properties during construction.
19. Before starting any construction the site must conform with the plans sanctioned and all the conditions as proposed by the plan should be fulfilled.
20. Design of all structural members including that of the foundation should conform to standards specified in the National Building Code of India.
21. All Building Materials or necessary & construction should conform to standard specified in the National Building Code of India.
22. For commencement of Erection/Re-Erection within Five Year will Require Fresh Application for Sanction.
23. Approved subject to Compliance of requisition of West Bengal Fire & Emergency Services, if any.
24. The building materials that will be stacked on Road/Passage or Foot-path beyond 3-months or after construction of G. Floor, whichever is earlier may be seized forthwith by the S.M.C at the cost and risk of the owner.
